Chair and Members:

Your Housing, Human Services, and Transportation Committee, having met on May 18, 2016, and August 18, 2016, makes reference to County Communication 16-53, from the Director of Housing and Human Concerns, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTIONS 14.34.090 AND 14.35.080 RELATING TO THE EXEMPTIONS FOR THE WASTEWATER ASSESSMENT FEES FOR FACILITY EXPANSION AND COLLECTION/TRANSMISSION SYSTEM UPGRADE."

Chapters 14.34 and 14.35, Maui County Code, established wastewater assessment fees for the expansion of the Kihei wastewater treatment plant and the upgrade and expansion of the Kihei wastewater transmission system, and the expansion of the Wailuku/Kahului wastewater treatment plant, respectively. The purpose of the proposed bill is to amend the exemptions from these wastewater assessment fees and allow the exemptions to apply to developments that are comprised of 100 percent residential workforce housing units, as defined in Section 2.96.020, Maui County Code.

The Director of Housing and Human Concerns said the proposed bill will make Sections 14.34.090 and 14.35.080, Maui County Code, consistent with the Residential Workforce Housing Policy. No other changes have been proposed by the Department.

The Deputy Director of Environmental Management said the County is charging wastewater assessment fees in Kihei and Wailuku-Kahului only. The fees are used to recover costs incurred by the County for expansion and upgrades to the wastewater system.

Your Committee requested information from the Department of Environmental Management concerning wastewater assessment fees collected for the last five years, projects exempted from those fees, and the impacts of exemptions for residential workforce housing units on future development or upgrades to wastewater treatment plants.

The Deputy Director said the Department has finished paying for the collection system upgrades in Kihei, so the Department plans to propose deletion of those wastewater assessment fees from the Code. He also explained the projects listed in Attachment "C" to the Department's response dated June 29, 2016, were not required to pay wastewater assessment fees because they are exempt under the Code. He said the assessment fees should be reviewed to determine whether further exemptions should be allowed and whether the assessment fees for upgrades and expansion for the Kihei system are still warranted.

Your Committee notes public schools are not treated consistently in the two areas. Public schools are exempt from wastewater assessment fees in Kihei, but not in Wailuku-Kahului.

Your Committee notes further discussion is needed with the Department of Environmental Management to determine whether assessment fees and exemptions should be updated in the Code, and to consider how existing Code requirements are being implemented. Therefore, your Committee recommended the matter relating to wastewater assessment fees other than those relating to the Residential Workforce Housing Policy or housing projects, be referred to your Infrastructure and Environmental Management Committee, along with a copy of the Department's response dated June 29, 2016.

Your Committee voted 6-0 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Crivello, Vice-Chair Baisa, and members Carroll, Couch, Guzman, and Victorino voted "aye." Committee member Hokama was excused.

A BILL FOR AN ORDINANCE AMENDING SECTIONS 14.34.090 AND
14.35.080, MAUI COUNTY CODE, RELATING TO THE EXEMPTIONS FOR THE
WASTEWATER ASSESSMENT FEES FOR FACILITY EXPANSION
AND COLLECTION/TRANSMISSION SYSTEM UPGRADE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 14.34.090, Maui County Code, is amended to read as follows:

"14.34.090 Exemptions. This chapter shall not apply to those developments granted building permits after January 1, 1989 and are:

A. County housing projects and other [county] County facilities[;].

[B. Affordable housing units which, for a period of five years after the original purchase, are:

1. Sold to the county of Maui at a price which shall not exceed the sum of:

- a. The original cost to the purchaser,
- b. The cost of any improvements added by the purchaser, and

- c. Simple interest on the case equity of the property at the rate of seven percent a year, pursuant to section 2.86.610B6aiii, of this code.

2. If the county does not exercise its right to purchase the unit, the homeowner may sell the unit at the market price, but must pay the county the assessment.

3. Within the five-year period, the homeowner may pay the assessment, in which case the unit may be sold at the market price.

4. The terms of the exemption from the assessment fee shall be set forth in a unilateral agreement. The agreement shall be recorded with the bureau of conveyances or the land court and the agreement shall run with the land and shall bind and constitute notice to all subsequent grantees, assignees, mortgagees, lienors, and any other person who claims an interest in the property. The agreement shall be

enforceable by the county, by appropriate action at law or suit in equity, against the parties and their heirs, personal representatives, successors, and assigns;

C. Accessory dwellings which meet affordable housing requirements;]

B. Comprised of one hundred percent residential workforce housing units, as defined in section 2.96.020 of this code.

[D.]C. Churches[;].

[E.]D. Public schools."

SECTION 2. Section 14.35.080, Maui County Code, is amended to read

as follows:

"14.35.080 Exemptions. This chapter shall not apply to those developments that are:

A. County housing projects and other [county] County facilities[;].

[B. Affordable housing units which, for a period of five years after the original purchase, are:

1. Sold to the county of Maui at a price which shall not exceed the sum of:

a. The original cost to the purchaser;

b. The cost of any improvements added by the purchaser; and

c. Simple interest on the cash equity of the property at the rate of seven percent per year, pursuant to section 2.86.610B6aiii, of this code.

2. If the county does not exercise its right to purchase the unit, the homeowner may sell the unit at the market price, but must pay the assessment.

3. Within the five-year period, the homeowner may pay the assessment, in which case the unit may be sold at the market price.

4. The terms of the exemption from the assessment fee shall be set forth in a unilateral agreement. The agreement shall be recorded with the bureau of conveyances or the land court and the agreement shall run with the land and shall bind and constitute notice to all subsequent grantees, assignees, mortgagees, lienors and any other person who claims an interest in the property. The agreement shall be enforceable by the county, by appropriate action at law or suit in equity, against the parties and their heirs, personal representatives, successors, and assigns;

C. Accessory dwellings which meet affordable housing requirements;]

B. Comprised of one hundred percent residential workforce housing units, as defined in section 2.96.020 of this code.
[D.]C. Churches.”

SECTION 3. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 4. This ordinance shall take effect upon its approval.



SUBJECT: EXEMPTIONS FROM CERTAIN WASTEWATER ASSESSMENT FEES FOR RESIDENTIAL WORKFORCE HOUSING UNITS (HHT-31)

In response to your June 21, 2016 request for information regarding Wastewater Assessment Fees currently charged in the County of Maui and the effect of exemptions we offer the following:

1. Provide an itemized list of wastewater assessment fees as set forth on page 47 of Appendix B - Fees, Rates, Assessments and Taxes of the Fiscal Year 2016 Budget, collected for the last five years. Include the project name, amount of the fee, and calculation of the fee.

Wastewater Assessment Fees are currently collected for new construction or alteration projects that will have wastewater treated at either the Kihei or Wailuku-Kahului Wastewater Reclamation Facilities (WWRF's). These fees are collected for individual structures (not entire subdivisions) as their building permits are issued by the Department of Public Works Development Services Administration (DSA). Itemized lists of fees paid in each assessment area were extracted from the KIVA Permit database and are provided in Attachments "A" (Kihei WWRF) and "B" (Wailuku/Kahului WWRF) for the time period of January 2011 through June 2016.

2. *Provide an itemized list of projects or development exempted from wastewater assessment fees for the last five years. Include the project or development name, amount of the fee waived, and calculation of the fee.*

Attachment D" itemizes all projects which were exempt from paying assessment fees from January 2011 thru June 2016.

3. *Explain the impacts of exemptions from certain wastewater assessment fees for residential workforce housing units on future development or upgrades to wastewater treatment plants.*

The purpose of wastewater assessment fees is to recover the construction cost of expanding infrastructure in order to support future development. They represent a fair share of the costs to provide the infrastructure required to develop a property. Exempting entities from paying these fees adds burden to the County of Maui, the Wastewater Reclamation Division and ultimately the sewer and recycled water customers.

- a. The County fronts the money for the expansion of a treatment facility or capacity upgrades of the collection system. Repayment is contingent on having available capacity. If increments of capacity are given to developers for free by exempting them from fees, then a potential is created for not reaching full payback.
- b. The Wastewater Reclamation Division operates on a special fund. Operating funds are based solely on monies generated through sewer and reclaimed water billings and assessment fees. If funds are not received via assessment fees then future projects may (1) need to be postponed or cancelled, or (2) current user rates (monthly sewer billings) may need to be raised to meet the deficit. This creates a potential for system malfunctions/failure due to aging equipment/assets or creates escalating financial burdens on all customers.
- c. Sewer and recycled water customer payments account for the majority of the sewer fund. Raising rates places the burden of paying for any exemption on them instead of the Maui taxpayers. If it is County Council's desire to have Maui County support affordable or workforce housing then the funds should come from the taxpayers (general fund) and not on the rate payers. In that way the load is spread equally on all of our citizens and not a greater percentage on the subset of sewer/recycled water customers. Attachment "D" lists projects currently planned with the potential for exempted fees.
