Chair and Members:

Your Policy and Intergovernmental Affairs Committee, having met on August 29, 2016, makes reference to County Communication 15-5, from Councilmember Mike White, relating to nominations to boards, committees, and commissions.

By correspondence dated and received August 12, 2016, the Mayor transmitted a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF KRIS MCPHEE, ALTERNATE, TO THE URBAN DESIGN REVIEW BOARD," along with a completed application form for the nominee.

The purpose of the proposed resolution is to approve or disapprove the appointment of Kris McPhee as an alternate to the Urban Design Review Board, for a term expiring on March 31, 2017, to fill a vacancy due to the resignation of Gerard Steiner.

Your Committee notes general appointment procedures for the Board are provided in Section 2.41, Maui County Code. Specific provisions for the Board are provided in Sections 2.26.030 and 2.40.100, MCC, and Section 13-2(1), Revised Charter of the County of Maui (1983), as amended.

Your Committee further notes there is no deadline for Council approval or disapproval of the Mayor's nominee.

A representative of the Mayor stated Mr. McPhee is an engineer, as required for this position.

Your Committee expressed its appreciation for Mr. McPhee's experience and willingness to serve on the Board.

Your Committee requested the Mayor's representative determine whether an alternate can be considered for regular membership if a vacancy should occur.

Your Committee voted 8-0 to recommend adoption of the proposed resolution. Committee Chair Victorino, Vice-Chair Couch, and members Baisa, Carroll, Cochran, Crivello, Guzman, and Hokama voted "aye." Committee member White was excused.
