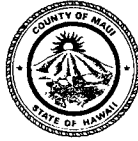

BILL NO. _____ (2016)

A BILL FOR AN ORDINANCE AMENDING SECTION 6.04.040,
MAUI COUNTY CODE, RELATING TO ANIMAL REGULATIONS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 6.04.040, Maui County Code, is amended by
amending subsection A to read as follows:

“A. An owner of a dog shall keep the dog under restraint,
except for the following:

1. A dog being used by law enforcement agencies for
law enforcement purposes[;].

2. A dog used during hunting, accompanied by its
owner, and used with the consent of the owner of the real
property upon which the hunting occurs[;].

3. A dog used during organized competitions, or
during training for such competitions, accompanied by its
owner, and used with the consent of the owner of the real
property upon which the dog is used[; and].


4. A dog being monitored by its owner or handler
within the confines of an authorized dog park.

5. A dog actively working on authorized farm or
ranch property.”

SECTION 2. Material to be repealed is bracketed. New material is
underscored. In printing this bill, the County Clerk need not include the
brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.
