Chair and Members:

Your Infrastructure and Environmental Management Committee, having met on September 12, 2016, makes reference to County Communication 15-107, from the Director of Public Works, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 10.44, MAUI COUNTY CODE, RELATING TO SPECIAL STOPS."

The purposes of the proposed bill are to address traffic and safety concerns by: 1) deleting the stop requirement at Mikioi Place for vehicles traveling along Akala Drive, Kihei, Maui, Hawaii; and 2) establishing a stop requirement at Limahana Place for vehicles entering from Hinau Street, Lahaina, Maui, Hawaii.

Your Committee noted the Public Works Commission unanimously recommended approval of the proposed bill at its meeting of November 19, 2014.

Your Committee discussed the stop requirement at Mikioi Place and Akala Drive in Kihei, noting the two-way stop on Mikioi Place is incorrectly referenced in the Code as a two-way stop on Akala Drive.

The Director of Public Works said the Department received complaints about the intersection, citing issues with sight distance on the left- and right-hand sides of Mikioi Place, and difficulty navigating through oncoming traffic from Akala Drive.

The Department conducted a site inspection and recommended the stop requirement be changed to a four-way stop on Mikioi Place and Akala Drive.

Your Committee noted the four-way stop was implemented in January 2014, two years before transmittal for Council approval.

The Director said the four-way stop is working well for the area and no complaints have been received.

Your Committee also discussed the proposed stop requirement at Limahana Place and Hinau Street in Lahaina.

According to the Director, the State Department of Transportation was concerned with traffic backing up onto Honoapiilani Highway because there is no stop requirement on Limahana Place in the northbound direction. A stop requirement on Limahana Place in the southbound direction already exists.

The Department conducted a site inspection and recommended removal of the stop requirement on Hinau Street and addition of a stop requirement on Limahana Place in the northbound direction to ease traffic concerns.

The Director said future plans will also include curb extensions and crosswalks on both streets because an increase in surrounding businesses has led to more vehicular and foot traffic in the area.

If approved, the traffic reconfiguration at Hinau Street and Limahana Place will take approximately six months. The Director said the public will be notified promptly when construction commences.

Your Committee voted 5-0 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Cochran, and members Baisa, Carroll, Guzman, and White voted "aye." Committee Vice-Chair Hokama and member Crivello were excused.

Your Committee is in receipt of a revised proposed bill, approved as to form and legality by the Department of the Corporation Counsel, entitled

A BILL FOR AN ORDINANCE AMENDING SECTION 10.44.050,

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:
