Regarding the numbers on the Supplemental not "jiving":

Budget office, derived \$601,432 from the approved ordinance for our department under the SNAP program

Regarding the budget amendment reflecting \$1,005,000 –

Budget calculated this amount by adding the Federal funds for the Annual SNAP grant 14-VA-01 which is \$311,800 + the Federal SNAP Supplemental award which is \$692,175

$311,800 + 692,175 = 1,003,975.00$  which is rounded up to 1,004,000.00

Budget office likes to account for a buffer / wiggle room and added an additional \$1,000 bringing the request to \$1,005,000

The amended request is \$1,005,000 – the approved ordinance of 601,432 = 403,568
