This AMENDMENT NO. 1 TO CONTRACT is made and entered into by and between the COUNTY OF MAUI, a political subdivision of the State of Hawaii, whose business address is 200 South High Street, Wailuku, Maui, Hawaii 96793, hereinafter referred to as the "County", and TYLER TECHNOLOGIES, INC., a Delaware corporation, whose mailing address is 5519 53rd Street, Lubbock, TX 79414, hereinafter referred to as the "Contractor." County and Contractor shall hereinafter be referred to collectively as the "Parties".

Source of Funds. The source(s) and availability of the funds for this Contract shall be as set forth in the Contract Certification signed by the Director of Finance of the County of Maui on or before the effective date of this Contract. Contract Certification shall be on file in the office of the Director of Finance of the County of Maui.

<u>RECITALS</u>:

1. WHEREAS, the County and the Contractor entered into the following Contract and Amendment(s), if any, with certified availability of funds in the amount indicated and time of performance as indicated:

2. WHEREAS, the Contract and any Amendment(s) thereto listed above shall be hereafter collectively referred to as "Contract"; and

- 3. WHEREAS, the Contract is on file with the Director of Finance; and
- 4. WHEREAS, the Parties now desire to amend the Contract.

NOW, THEREFORE, the Parties mutually agree to amend the Contract as follows:

- 1. The Statement of Work is hereby amended as follows:
 - a. Two weeks of fundamentals training will be allocated to Stage 1, with one week of fundamentals training being moved to Stage 3. Exhibit B UPDATED has been revised to align with this change (see edits to Deliverable 3-4 in paragraph 2.1).
 - b. The task"provide remote access (when needed) to required server for Tyler
 Software installation and System Configuration," originally allocated to
 Stage 2, shall be moved to Stage 3.
 - c. The task "deploy prototype configurations into the Production testing environment," originally allocated to Stage 2, shall be moved to Stage 3. Tyler's responsibility will change to "Advise."
- 2. Time of Performance is hereby amended as follows:

The Contractor has commenced performance of professional services under this Contract upon issuance of the Contract Certification dated June 30, 2015, and shall continue performance of those services through December 31, 2018, except as otherwise agreed to.

3. The total not-to-exceed amount as stated in the Contract is hereby increased by the amount of additional certification requested as set forth hereinabove, subject to appropriation and inclusive of all taxes. The fee or compensation schedule as set forth in the May 25, 2016 updated version of Exhibit B is hereby added to the Compensation provision of the Contract. A copy of said document is maintained and on file in the office of the Director of Finance of the County of Maui and incorporated herein by reference and hereby made a part of the Contract.

Harware fees of \$149,750.00 are hereby removed from scope. Client will directly procure any required hardware, and shall make payment directly to any third-party hardware vendor. Conforming edits have been made to the May 25, 2016 updated version of Exhibit B (see Exhibit B -UPDATED, paragraph 3).

4. For the avoidance of doubt, and notwithstanding any errant reference to the contrary in the Agreement, the parties agree to the following:

a. the System Acceptance/UAT stage is Stage 9, not Stage 8; and

b. Client did not license Tyler's LRM software module.

The entire Contract, as amended herein, shall remain in full force and effect.
