Rule 10. Roll Call.

- A. For Council meetings, the Clerk shall call the roll of members as required by the Chair.
- B. For a roll call vote, a failure to vote by any non-abstainting voting member who is present and whose name is called by the Clerk two times shall be deemed an affirmative vote in accordance with Rule 9(B).
- <u>C.</u> For Council meetings, the Clerk shall announce the result of roll call votes.
