- 1. Keonekai Road, Kihei Approximately 160 feet west of Kanakanui Road.
- 2. South Kihei Road, Kihei Approximately 800 feet north of Kilohana Drive.
- Waiale Road, Wailuku, approximately 600 feet north of Kaupo Street.
- 4. Papa Avenue, Kahului, approximately 350 feet east of Molokai Hema Street.
