This is with regards to your letter addressed to Chief Court Administrator Sandy Kozaki, dated November 3, 2016. The letter discussed a scheduled meeting in the Council Chamber on November 28, 2016 at 1:30 p.m. dealing with the above noted subject area and requested assistance with the following:

1. Please provide a copy of all title reports for Hui Roads B through F, H and I.

At the present time, we do not have any title reports in our possession. We have been trying to get a quote and subsequently have a title report prepared for Hui Roads B,C,D,E F,H and I from Title Guarantee Escrow Service Inc. since July 28, 2016. So far, all our follow up contacts and efforts have not been successful. Title Guarantee has indicated that they have been having a difficult time in preparing such a report. We will continue to follow up and provide any updated status as it becomes available.

2. Please advise whether you or a designated representative are available to attend the November 28 meeting as resource personnel.

We will not be available to attend the November 28 meeting as I will be out on vacation leave.

We would like to thank you for your efforts in this matter. As you are aware, the Clerk of the Court holds title to the subject Hui Roads as a passive trustee, with no duties whatsoever to construct, build, maintain or repair any of such roadways. As we do get

complaints from residents dealing with the condition of the roadways but are not in a position to do anything about it, we would be very supportive of conveying title of the roads to the County of Maui. Should you have any questions, please feel free to contact me at 244-2855.
