I am writing in opposition to the proposed resolution to authorize Maui County to lease the Old Maui High School Site (Hamakuapoko) to Teach Development LLC. Teach LLC has made wonderful verbal promises to farmers and non profits, but unless their promises are written into the lease, TEACH LLC is not required to fulfill those commitments. Teach LLC should be required to pay market rent, at the very least after 10 years. Their projected profit after 5 years is estimated at \$17 million. There is no need to give the land for next to nothing.

Long-term investment horizons usually have to phase out in 10-20 years, or sooner, and rarely go over 30. This is a 60-year lease. Certainly no one believes it will take 60 years to make the investment worthwhileyy. At some point in the future there should be a catch-up and/or correction of lease terms to approximate market pricing.

Please defer further action on EAR-63 and ask the Administration to reconsider this private commercial land development proposal.

Aloha and Good Afternoon Chair Guzman and Councilmembers,

My name is Martin Brass. I am a Paia business and property owner. I would like to first commend the efforts of this Committee, the Mayor's office and the various County departments involved in the efforts to redevelop the Old Maui High School property. I preface my following comments by stating I do not stand here today to question the County's intentions. However, I am gravely concerned with the financial terms of the lease being offered to Teach Development.

In my reading of EAR 63, I see a gross inequity between risk and return to Maui County in the proposed lease. Typical Public/Private Partnerships have a sharing of risk. One partner (typically the public sector) bears a disproportionate share of risk to allow the other partner (typically the private sector) to earn an accelerated return. At some point in the future an allowance is made for the public sector to earn its share of return.

In this case, the lease proposes a flat rent of \$1/year for 23 acres of prime land for sixty years. There is no catchup for the County. Given the scope and cost of the proposed project, I don't see any participation in the project's returns, at all.

Let's put this in perspective:

- 1) Teach Development proposes developing 200,000 sf. That is roughly 1.5x the size of Paia's current commercial square footage.
- 2) Long term Investment horizons usually have to pencil out in 5-7 years, and typically have to generate cash flow sooner than that. Investment horizons rarely exceed 15-20 years. This is a 60 year lease. Certainly no one believes it will take 60 years to make this investment worthwhile.
- 3) Approximately \$60 million of investment is anticipated being made. Given that typical baseline ROIs (Return on Investments) are 10-15% and assuming the low end of 10%, implied annual returns would be \$6MM/yr. That is a 10 year payback on the \$60 million in capital invested. The County meanwhile has earned only \$10. You can make the same assumption with a 5% ROI with a 20 year breakeven on the same \$60 million investment. The County still has only collected \$20 in rent.
- 4) Another way to look at this. Consider that the proposed lease is effectively a 60 year land lease. Based on the stated \$1/year rent, a 5% cap rate could be applied that would give a \$20 valuation. Effectively the County has sold 23 acres for a \$20 bill with this lease.
- 5) A better structure is to have market rate catch-ups on the rent for the County. Let the Developer have preferred returns, for a period of time but the County and the community should benefit at some point

too. The current lease seems to have too many unknowns such as subletting the property which I fear will only end up costing the County and its residents lost opportunities and revenue.

I respectfully request the Committee to defer any further action on approving EAR 63 until such time as a careful review is prepared of the financial structure, returns and risks to the County and Public. I believe we can do better, earn more revenue and deploy the monies as needed elsewhere.

The project has the look of permitting "corporate welfare" by the County. The \$1 a year lease is outrageous for a for-profit enterprise. Ask them to justify the \$1 a year lease. 6. Their overall education plan gives no actual plan as to the educational programs they hope to provide. They don't state the curriculum/lessons/standards/etc that they will use and for which targeted educational groups--all things that educational efforts should have already considered and would need to present in a master plan and or program guide. 7. They say they will use Hawaiian methods and ahupua'a teaching but they they don't say which teachings, how they will teach ahupua'a, and who from the community will teach it. What ahupua'a model are they following? I don't know of any one model and method (and I was the Hawaiian Studies program manager for the DOE). Educational programs have to be explained and they teaching methods and measures (how they will measure educational program outcomes--are missing). 8. The traffic and all the other environmental and community impacts should have been spelled out in the EIS--which they have not done, so there is not way to know of the physical impacts at this point. These are just some thoughts that can be shared. It's a good sign that the County Council hasn't already passed the Resolution that will allow this project. needs to do due diligence. But you can ask them if anything in the actual plan has changed to warrant them passing it now. This is a hot mess for the community--I wish I was there to be there!!

Continued growth, expansion and urbanization into our rural areas is not the long-term solution which the population of Maui County should support. We live on an island where our limited resources confine our ability to expand. Lack of water, land and food constrain our abilities as a community to support our current populations. With that said, we should respect our inability to grow and foster our current population rather than to expand our infrastructure to accommodate more. In a time where long time Maui residents struggle to find homes, jobs and resources, I feel our focus would be better spent nurturing our own rather than the influx of big business, transplants and urban expansion. This opinion is in reference to the Old Maui High School Land Proposal, which I am firmly against.

Infrastructure alone should be reason enough to squash this proposal. The Haiku and Kuau areas are unequipped to manage the influx in commuter traffic caused by this proposal. Even if additional schools and a bypass were created it would still be unable to properly redirect traffic to support the area's needs.

Environmental impact is another major factor which I feel needs to be taken into account. Hookipa and the Kuau area heavily populated with marine life. What reassurance does Maui County's residents have that the most innovative, responsible and environmentally correct procedures will be used to ensure that the reefs of the North Shore aren't degraded by this development. If destruction of these resources does occur will you allow us to hold the party responsible liable for the damages? This is our aina and if you wish to sell it off for profit then perhaps the purchasing party should be responsible for their actions? This just seems like common decency to me.

The proposed increase in jobs is another topic, which I believe is being mistaken in the wrong direction.
