THE REGULAR MEETING OF THE COUNCIL OF THE COUNTY OF MAUI, STATE OF HAWAII, WAS HELD IN THE COUNCIL CHAMBER, KALANA O MAUI BUILDING, WAILUKU, HAWAII, ON FRIDAY, OCTOBER 21, 2016, BEGINNING AT 9:03 A.M., WITH CHAIR MICHAEL B. WHITE PRESIDING.

CHAIR WHITE: This meeting of the Council of the County of Maui will please come to order.

Mr. Clerk, will you please call the roll.

COUNTY CLERK: Thank you, Mr. Chair.

ROLL CALL

PRESENT: COUNCILMEMBERS GLADYS C. BAISA, ELEANORA COCHRAN, DONALD G. COUCH JR., S. STACY CRIVELLO, G. RIKI HOKAMA, VICE-CHAIR DONALD S. GUZMAN, AND CHAIR MICHAEL B. WHITE.

EXCUSED: COUNCILMEMBERS ROBERT CARROLL AND MICHAEL P. VICTORINO.

COUNTY CLERK DENNIS A. MATEO: Mr. Chair, seven Members present and two excused. Quorum is set to provide business for the Council today.

CHAIR WHITE: Thank you, Mr. Clerk.

And, Member Carroll is stuck in Hana or is on his way, but they've had some power outages and so he's, he'll be delayed for a while. So, we will forgo our opening remarks and have him provide those when he gets here, if he gets here before the meeting's over.

So with that, I would like to ask everyone to please rise and join me in the Pledge of Allegiance.

PLEDGE OF ALLEGIANCE

The Members of the Council, and others in attendance, rose and recited the Pledge of Allegiance.

CHAIR WHITE: Thank you. And before we move forward, please make sure your cellphones are placed on silent.

Mr. Clerk, let's proceed.

COUNTY CLERK: Mr. Chair, proceeding with the presentation of testimony on agenda items. We have established limited telephone interactive communication that enables individuals from Hana, Lanai, and Molokai to provide testimony from our District Offices.

Individuals who wish to offer testimony from Hana, Lanai, and Molokai should now sign up with the District Office staff. Individuals who wish to offer testimony in the chamber, please sign up at the desk located on the eighth floor lobby just outside the chamber door. Testimony at all locations is limited to the items listed on today's agenda.

And pursuant to the Rules of the Council, each testifier is allowed to testify for up to three minutes with one minute to conclude if requested. And when testifying, please state your name, and the name of any organization you may represent.

Hana Office, please identify yourself and introduce your first testifier.

CHAIR WHITE: They have a power outage out there, so that may be the reason they're not responding.

COUNTY CLERK: Lanai Office, please introduce yourself, and introduce your first testifier.

Molokai Office, please introduce yourself, and introduce your first testifier.

Mr. Chair, we seem to have an issue with our communication at this time.

CHAIR WHITE: Let's proceed with testimony in the chambers, and maybe staff can reconnect the District Offices, if that can be done without interrupting testimony. Okay, so please call the first testifier and then.

COUNTY CLERK: Mr. Chair, the first testifier who have signed up to provide testimony in the chamber this morning, Cassandra Abdul, providing testimony on Bill 96 and 97, to be followed by Tom Blackburn-Rodriguez.

PRESENTATION OF WRITTEN OR ORAL TESTIMONY

MS. CASSANDRA ABDUL [testifying on Bill 96 (2016) and Bill 97(2016)]:

Good morning, Chair White.

CHAIR WHITE: Good morning.

MS. ABDUL: --Councilmembers. Na Hale O Maui was created as a grassroots organization that became a non-profit entity "To secure and preserve a permanent supply of affordable housing alternatives for low and moderate income households in Maui County."

We support all efforts to develop affordable housing in Maui County. Our business model is based on a 99-year sustainable ground lease; renewable for another 99-year term. The home can be inherited by children or repurchased by Na Hale O Maui and sold to another income-qualified family.

CLT homes help families build and accumulate wealth. They may share up to approximately 25 to 50 percent of any appreciation. To date, two homeowners received more proceeds under our two-step resale formula than they originally invested in their home.

Na Hale O Maui updates and rehabilitates the homes before reselling them to a new income-qualified family at an affordable price. This reassures us that public funds invested in the CLT home today will act as a kind of perpetual endowment of Community Land Trust affordable housing, generation after generation, buyer after buyer.

We respectfully request your support to further Na Hale O Maui's program and contribute to Maui County's goal of delivering affordable housing solutions. Your favorable approval of Bill 96, awarding 660,000 from the Affordable Housing Fund,

will assist Na Hale O Maui with the vertical construction of Community Land Trust homes in the Kahoma workforce housing subdivision in Lahaina. This grant will be a catalyst, empowering Na Hale O Maui to deliver 12 new affordable homes in perpetuity for income-qualified families who work and/or live on the West Side.

Mahalo for your unwavering support of affordable housing and for the Na Hale O Maui's CLT model that provides affordability in perpetuity.

CHAIR WHITE: Thank you, Ms. Abdul.

Members, any need for clarification of the testimony? Seeing none, thank you very much for being here this morning.

MS. ABDUL: Thank you. I'd like to also testify on Bill 97, just briefly.

CHAIR WHITE: Oh please proceed.

MS. ABDUL: Okay. We need to use all of the tools that we have for affordable housing here in Maui. I know that no one organization can do it all, and no one way is the only way to accomplish our goals. I ask that you support and pass Bill 97 for Habitat for Humanity's 10 homes and lots in the same Kahoma subdivision.

Habitat serves a different income-qualified group than Na Hale does. But, together we can build 22 homes for families earning less than 120 percent of AMI. Mahalo for your support.

CHAIR WHITE: Thank you, Ms. Abdul.

Members, any need for clarification? Seeing none, appreciate your testimony this morning.

Mr. Clerk.

COUNTY CLERK: Mr. Chair, the next testifier is Tom Blackburn-Rodriguez, consultant, testifying on Bill 96 and 97 on behalf of Go Maui, Hawaii.

MR. TOM BLACKBURN-RODRIGUEZ [testifying on Bill 96 (2016) and Bill 97 (2016)]:

Good morning, Mr. Chairman.

CHAIR WHITE: Good morning--

MR. BLACKBURN-RODRIGUEZ: --Members of the Council. Thank you very much for the opportunity to testify. I'm representing Go Maui. It's a nonpartisan, nonprofit, 501(c)(4) organization, focusing on issues of employment, housing, water, and other issues that may come up before the community.

We are in strong support of both Bills 96 and 97, Na Hale O Maui and Habitat for Humanity. And while I will be supporting both bills, I do not intend to take additional time beyond my three minutes, Mr. Chairman.

I simply want to thank yourself, the Council, Mr. Hokama, the members of the Administration, and also the folks in Housing and Human Concerns, for all the work that you put in in order to make this happen on this particular day.

Nonprofit development will not solve the problem. But it can, it can show the way with models that can be followed, and with pilot projects, and do that in a way that allows us to learn the lessons we need to learn in order to build affordable housing. Lessons that are being discussed in the TIG report, which I think is a major step forward.

I want to thank Member Cochran, and also Member Baisa, and Member Couch, for their work on doing that, as well as their staffs.

So in conclusion, we'd like to say that Go Maui really, really appreciates the fact that this Council will not walk away from this issue no matter how difficult it is, and how challenging it may become. Thank you very much. And we urge your support for both Na Hale O Maui and for Habitat for Humanity. Aloha.

CHAIR WHITE: Thank you very much.

Ms. Baisa.

COUNCILMEMBER BAISA: Thank you very much, Chair. If I might have just a second of personal privilege. I'd like to wish Mr. Blackburn a happy birthday. Today is a birthday day here. We have him and Sandy.

MR. BLACKBURN-RODRIGUEZ: Thank you. And to my brother Sandy Baz, a very happy birthday. Aloha.

CHAIR WHITE: Thank you very much.

Members, any need for clarification of his testimony?

Seeing none, appreciate your offering your mana`o this morning.

MR. BLACKBURN-RODRIGUEZ: Thank you.

CHAIR WHITE: Mr. Clerk.

COUNTY CLERK: Mr. Chair, the last individual who has signed up to testify in the chamber is Eric Romanchak, testifying on County Communication 16-249.

MR. ERIC ROMANCHAK, (testifying on County Communication No. 16-249):

Good morning--

CHAIR WHITE: Good morning.

MR. ROMANCHAK: --Council Chair Mr. White, fellow Councilmembers.

COUNCILMEMBER COUCH: Mr. Chair, can we get him to?

CHAIR WHITE: Yea, if you could please bring the mic a little closer to your--

MR. ROMANCHAK: Sorry. My name is Eric Romanchak. I am here as indicated, to briefly ask for this Council's support to forward the bill for an ordinance amending Section 14.13.065.

This is the matter that has been before the Council now for a couple of years. It relates to exemption from fire protection dealing with the Upcountry water meter list, a matter that has been before the Council. I know a number of times I've been in Council chambers when these issues have been discussed. I've been following this issue for probably 25 years, going back to the mid-1990's.

But this particular effort on the part of the Council, I think, is important. It does recognize that sometimes ordinances have such strict requirements to try to address issues countywide. And you come into situations as we have Upcountry that sometimes it just doesn't make sense. And the bill that was passed last year was a major step in the direction of recognizing that, I believe.

The, the matter that is at this time being asked to be forwarded to the Water Resource Committee I think is important, because the bill should be looked at, in my view of course, again. The idea here is that it, rather than being a exemption for two lots or less subdivision. Makes sense that it included what we would normally refer to three-lot subdivision. Something that has been going on Upcountry for years, have in the past been given certain exemptions recognizing the small subdivision sometimes are just overburdened by a very strict rule that applies countywide.

I think the Water Resource Committee should look at it again. See whether or not three lots or less makes sense as it did when you passed it for two lots or less. I think that was the original intent of the bill, as I remember from last year. And, thank you.

Addressing it again, I think is important. So I'm here simply to say pass it on to that Committee. Let them look at it again. See whether the bill needs to be tweaked in anyway. But, look at the benefit that it really does provide for those of us Upcountry that have so long been waiting for something that makes sense, and I believe this bill does. So, I would urge the Council to refer it to that Committee as soon as possible so that Committee can take a look at it and hopefully report back and move forward. Thank you.

CHAIR WHITE: Thank you, Mr. Romanchak.

Members, any need for clarification? Seeing none, thank you for being here this morning.

MR. ROMANCHAK: Thank you.

CHAIR WHITE: Mr. Clerk.

COUNTY CLERK: Next testifier is Sherman Dudley DePonte, testifying on County Communication 16-249. And Mr. DePonte will be followed by Dane Dingerson.

MR. SHERMAN DUDLEY DEPONTE (testifying on County Communication No. 16-249):

I'm Sherman Dudley DePonte from 17529 Haleakala Highway. I've been in front of the Council, in front of the boards, in front of everything. Eric has been here since 1990, I've been 1992. But, I've been doing land surveying, which I'm a professional land surveyor in this community for 41 years now.

And, and I keep butting heads with the Water Department, basically for the Upcountry people. At first it was basically for the Upcountry people. Now, I've hit home with my own. We need this fire protection looked at really seriously, because right now we have nothing. Councilmember Baisa helped push a bill that at least got us one water meter. So, the people Upcountry can at least do one, one extra lot, subdivision.

We're not asking for rezoning. What we're asking for is what is rightfully ours. We have been overlooked through the years. I feel that it is, you know, it's a shame for this County. We're part of this County. Upcountry people is a big part of this country, County, and country. We supply food, grow crops, we, we come out here as professionals and we do our work. We've tried praying, the red shirt, we've tried baking, we've tried begging, and we still haven't gotten what we needed for Upcountry.

This water bill makes sense because I, and I said it on one-hand. If you put ten fire hydrants in my, in my, on my property, right up against the house if you may, and let's, let's say that a fire breaks out. And ten with that 3.1 million that I have to put in, which I consider extortion, and a lot of people do also. But in any case, we put ten, give them more, the fire truck can't reach there. What happens to my house? Because it takes them 40 minutes to reach the, reach my house from a call. We've tested it. Okay, so 40 minutes, the house is down to the ground.

On my right hand, if we do private fire protection, sprinkler systems in the house, this one, when a fire goes off, it gets turned off. It, when you have a fire, it gets turned off almost immediately, already it's dousing; it's getting down. It just makes sense to me. This saves lives, this one won't. I mean, how do you save life in the ashes? This one does.

Councilmember Couch, you've followed up on the Fire Department. When you asked them how much of the fire would be out when they reach with the sprinkler system? They said, 90 percent. Ninety percent is better than zero. We need that. We can use that. Upcountry, we cannot go with the rules that we have down here in, in the city, because we have hills, we have mountains, we're, we're far away. We have roads that you can't reach us. And is this stopping me?

CHAIR WHITE: If you, if you need a minute to conclude, please continue.

MR. DEPONTE: Okay. But, in any case, we need bills that make sense. I wrote the, I wrote it from a professional point of view. I've interviewed professionals in the community. Fire protection professionals all went into this. What came out of this was one water meter that Councilmember Baisa finally got through.

We need more. The, I came in here and when they went down to the one water meter, I said I would yield because I'm looking for four lots for my, for my family. I can't get it. I'm going to get maybe one, maybe two, whatever extra. We need the, we need the second one. I was yielding to the two, three lots or less because that was in our codes before. We had three lots or less. It made sense.

You have two and a half kids. The . . . have kid, we no need. Anyway, the idea is it just makes sense to . . . for one more, one more water meter. But, I seriously ask Councilmembers to look at what, what we put into this--

COUNTY CLERK: Four minutes.

MR. DEPONTE: --what the professionals in our community put into this, and relook at it. And try to bring something better for Upcountry not only for the people on the water list, but for everyone. This is a community. This is for everyone. Not just for me, but for everyone. Thank you very much for your time. And I appreciate your efforts, and I, Councilmember Baisa and White, and everyone else for helping get this thing go through.

CHAIR WHITE: Thank you very much, Mr. DePonte.

Members, any need for clarification?

Seeing none, I appreciate your testimony this morning.

MR. DEPONTE: Thank you.

CHAIR WHITE: Mr. Clerk.

COUNTY CLERK: Next testifier is Dane Dingerson, testifying on County Communication 16-249, to be followed by Rosemary Robbins.

MR. DANE DINGERSON (testifying on County Communication No. 16-249):

Good morning, Council. I appreciate the opportunity to speak to you. This is my first time every testifying, but this is something that's important to me. You know the affordable housing--

CHAIR WHITE: If you could just mention your name for the record.

MR. DINGERSON: Oh I'm sorry. My name is Dane Dingson.

CHAIR WHITE: Thank you.

MR. DINGERSON: You know the, I think the affordable housing problem is a reflection of the housing problem. Maui has a shortage of housing everywhere. And, the small developers provide a portion of that, the big developers provide a bigger portion. This law restricts the small developer, and makes it harder for a person to, to develop a two or three lot housing division, excuse me, and the rule that it reflects on is important. And to a large developer, this is really essential. But, to a small person, I believe that allowing us to use alternate methods of fighting fires is going to be actually better, and it's going to bring more housing.

I've had a small two, three lot subdivision that's been waiting for a year, year and a half, it could wait longer. This just holds up housing, and I don't think it increases public safety. Thank you very much.

CHAIR WHITE: Thank you very much, Mr. Dingson.

Members, any need for clarification?

Mr. Couch.

COUNCILMEMBER COUCH: Thank you, Mr. Chair. And thank you, Mr. Dingson. Are you saying you don't support this bill that's going through?

MR. DINGERSON: I support the change from a two lot to three, which is what the bill refers to.

COUNCILMEMBER COUCH: Okay. Thank you.

CHAIR WHITE: Thank you very much for your testimony this morning.

Mr. Clerk.

COUNTY CLERK: Mr. Chair, the next individual is Rosemary Robbins, testifying on County Communication 16-249, and Bill No. 100.

MS. ROSEMARY ROBBINS [testifying on County Communication 16-249 and Bill 100 (2016)]:

Good morning, everybody. Rosemary Robbins, concerned citizen.

Bill 16-249 is a popular one on the agenda this morning, and rightfully so. I'd just like to mention that there's a lot of unrest in the community out there. Four items of the 26 items on our agenda today require executive meetings, meaning that folks in the community are barred from participating or attending these sessions. That's not a popular thing. I understand some of the reason for that. But, it seems to be a situation that's getting out of hand. Those meetings are for expenses to taxpayer settlements in cases filed against, not the taxpayers, but the people who have been appointed primarily within our government; not the people who were necessarily elected. Something's wrong with that in this government of, for, and by the people.

So, when we take a look at the 16-249 item on today's agenda, over on page 7. It talks about an ordinance amending Maui County Code relating to exemption from fire protection mainline infrastructure improvements for the Upcountry water system. We've heard good testimony this morning from that. We heard good testimony the other day in one of the other meetings where we were here. If somebody just wants to put in a bathroom in a house, it's the same thing as what's going to be held accountable for multi-units. It really isn't. So, I would ask us to be careful about that.

The other item that I would address this morning is Bill, excuse me, Bill No. 100. It's about crosswalks. Probably well-intentioned, many of the bills that get brought up before this Council. I have a particular one that I would like to thank for the situation in Makawao. We had security staff member at that library who got in touch with this body, and said there needed to be a very attractive crosswalk in the middle of, not the intersection of, a situation on Makawao Avenue. And you, thank you, came up to speak to her, that now has a flashing light, can't miss it, in terms of people crossing Makawao Ave., to be able to get across in safety without cars ripping through having just taken off from the intersection of Olinda. So, thank you for having responded to her. It's wonderful to see people with canes, with carriages, etc., safely walking across that road. And she and the rest of us who have born witness to that are very appreciative of the fact that you listened and acted, not just put it on an agenda for the future when the kids would be grown up and the senior with the cane would be dead. So, thank you for your timeliness on that.

I would also like to be able to draw attention to the fact from Maui Time that came out yesterday that talks about--

CHAIR WHITE: Ms. Robbins.

MS. ROBBINS: Yes.

CHAIR WHITE: You've testified on 16-249 and Bill 100. Are you testifying on a separate measure at this time?

MS. ROBBINS: No, I'm talking about what's driving this situation on all of these, is that we've got people who are appointed folks, not elected by the electorate, who are being aced out of opportunities to participate when commissions, including commissions but not just they, are saying but we're not going to handle this. And by the way, we're appointed on commissions. Wow, says the electorate. What happens to our voice up there? So all of this is tied into the fact that we've got people who are being left out. The neighborhood plans that are not going to be considered the way they were intended to be considered by the folks who live there. So, please don't let that continue as a process.

CHAIR WHITE: Okay. Thank you very much.

Members, any need for clarification? Seeing none, thank you for being here this morning.

MS. ROBBINS: You're welcome.

CHAIR WHITE: Mr. Clerk.

COUNTY CLERK: Mr. Chair, there is no further individuals signed up to provide testimony in the Council chamber. If there is any additional individual in the Council chamber or in the District Offices who would wish to provide testimony, please identify yourself to the appropriate staff or proceed down to the lectern podium at this time.

Mr. Chair, for the District Offices, all three District Offices has no one wishing to provide testimony this morning.

CHAIR WHITE: Okay. Thank you very much.

Members, we have received written testimony. Without objections, we'll receive that into the record.

VICE-CHAIR GUZMAN: Thank you, Chair. Your Committee met on October 4, 2016, to consider the proposed resolution authorized by the Mayor to enter into a lease with the Boys & Girls Club of Maui, Inc., of Haiku Clubhouse, for a term of 30 years, to expire on June 30, 2046, for an annual rent of \$1.

The Boys & Girls Club of Maui, Inc. has operated these programs since 2000 on a permit basis, serving over a hundred children daily, which many come from Haiku School to participate in the after-school activities.

The nonprofit intends to continue the use of the premises for a drop-in youth center for ages 9-17, with programs addressing character, leadership, education, career development, health, skill lifes *[sic]*, and arts, and fitness and recreation.

Pursuant to Section 3.36.090 of the Maui County Code, the Council may authorize, by resolution, the grant of the lease of the real property at less than fair market value.

The Director of Parks and Recreation said that the nonprofit provides a much-needed service in the Haiku community, and the Department fully supports the lease.

I respectfully ask the Members of the Council for full support of the Committee's recommendations. Thank you, Chair.

CHAIR WHITE: Thank you.

Mr. Couch.

COUNCILMEMBER COUCH: Thank you, Mr. Chair. I have to do a disclosure in that I am on the board of the Boys & Girls Clubs of Maui, and request that I be recused from this.

CHAIR WHITE: Your request is granted.

COUNCILMEMBER HOKAMA: Chair.

CHAIR WHITE: Mr. Hokama.

COUNCILMEMBER HOKAMA: Chairman, thank you. You know, I have a concern with, and I appreciate Mr. Couch's disclosure, I think that is very appropriate. So, one, I have a concern of the Committee's vote on whether or not it was appropriate to put Mr. Couch in that situation. But regardless on the ruling, whichever way you folks, you want to rule, Chairman.

My concern about this proposal, I understand the intent, I understand the mission of Boys & Girls Club, and I don't have an issue with that. What I am concerned about, cause it's happening on Lanai, is, does Boys & Girls Club have full use, cause I cannot read it in the terms, 24/7, of the areas that we leasing to them? Or does a portion go back for regular community use and needs during their non-hours of operation? Cause on Lanai, we have a concern of lack on facilities, and a lot of demand to use facilities.

So, I'm just wondering because it's not clear. I look at Exhibit "B", is it that whole portion that is under the term of this agreement? I would ask if Mr. Guzman can maybe help me get an understanding of, is it a portion of the community center or is it the whole complex of the community center that we are leasing to Boys & Girls Club?

CHAIR WHITE: Mr. Guzman.

VICE-CHAIR GUZMAN: Thank you, Chair. I'd like to take on the first matter on Mr. Couch's, I guess abstaining from voting at this stage. That is correct, we were at bare quorum at the time that this subject matter was brought forward in the EAR Committee.

I did ask several questions of Mr. Couch to, of his interest, and he had indicated that he had no other, you know, self-interest or individual-interest other than being on the board. And so, he had, I guess, believed, and I also believed that there was no conflict.

But at this stage, as it's coming out and on the floor, he has decided that there is a conflict, so therefore, I would, I would ask this, I guess, for your consent or at least permission to defer this back to the Committee for a proper vote on passing it through the Committee. Because it seems as though that without Mr. Couch's vote, if he believes that there was a conflict, then it definitely was not legitimately passed out of Committee. So, thank you.

In March 2015, the Council authorized the grant of a lease of County real property to Hitachi for the installation, operation, and maintenance of electric vehicle quick chargers and local battery units at the Haiku Community Center, Kihei Community Center, Lahaina Aquatic Center, and the County of Maui's Kalana building in Wailuku. The grant is part of the JUMPSmartMaui project – a pilot program and, that demonstrates a smart-grid technology and test how electric vehicles and stationary devices, including chargers and batteries, can stabilize Maui's electric power grid and support the use of higher levels of renewable energy on Maui.

The license agreement expired on March 31, 2016.

Pursuant to Section 3.36.090 of the Maui County Code, which requires the Council to approve any grant of a license of County real property at less than fair market value.

The County Energy Commissioner said the JUMPSmartMaui charging project has shown value to the grid, and the following phases will demonstrate virtual power plant design whereby vehicle contributes excess power back to the grid. He also said that the project has proven to be useful economic activity, bringing more than 700 clean vehicles to the County. And he added the Office of Economic Development supports the program.

Regarding 16-170, your Committee met on September 12, 2016, to consider two proposal, proposed resolutions to authorize the Mayor to enter into lease agreements with the State of Hawaii for the installation of emergency outdoor warning sirens at a total of 17 locations throughout the County.

Section 3.40.040(a)(3), Maui County Code, requires a lease of real property exceeding five years to any agency of the State government be authorized by the Council resolution.

The 17 sirens are solar-powered and include both upgrades and new installations. The sirens can be heard from a range of approximately 1.5 miles, and will add to much-needed emergency notification capabilities for the County.

The cost of the sirens and installation will be paid by the State.

I respectfully ask that the Members support both of these motions. Thank you.

COUNCILMEMBER COCHRAN: Thank you. I'll explain a little bit. Bill 99, and the purposes of the bill are to: 1) delete the stop requirement at Mikioi Place for vehicles traveling along Akala Drive, Kihei, Maui Hawaii; 2) establish a stop requirement at Limahana Place for vehicles entering from Hinaiu Street, Lahaina, Maui Hawaii.

And the bill will update the Code to reflect the traffic configuration at Mikioi and Akala implemented in 2014, from a two-way stop to a four-way stop.

The Department recommended removing the stop requirement on Hinaiu and adding a stop requirement on Limahana in the northbound direction to prevent traffic from Hinaiu backing up onto the Lower Honoapiilani Highway.

And Public Works Commission also voted unanimously to approve these proposed bills at its meeting on November 19, 2014.

On Bill 100, the purpose of this one is to establish a mid-block crosswalk fronting Kihei Holiday Resort, which is located at 483 South Kihei Road, approximately 1,525 feet south of Ohukai Road, Kihei, Maui, Hawaii.

And Public Works also unanimously recommended approval of this proposed bill at its meeting on December 16, 2015.

So, a crosswalk in this area is necessary to address traffic and safety concerns for pedestrians on South Kihei Road, allowing them to safely use the beach access located directly across the street, especially since the nearest crosswalk is located about 700-feet away on the north and south sides of Kihei Holiday Resort.

I please ask for Council's support on both these bills. Thank you, Chair.

COUNCILMEMBER COUCH: Thank you, Mr. Chair. Bill 101 would allow transient vacation rental use in planned developments with residential zoning containing a combination of single-family and multi-family dwelling units. But would not allow the use in planned developments containing exclusively single-family dwelling units.

The Planning Director advised that the proposed bill will apply only to the Alaeloa development on the island of Maui. Alaeloa is a planned development containing a combination of single-family and multi-family dwelling units.

This would have gone through with the bill that passed the Puamana development, and, but at the request of Ms. Cochran, we pulled it out just to make sure that the folks there wanted it. And we did get a letter from the AOAO requesting that it be put back in.

So, I ask for the Council's support of my motion. Thank you.

CHAIR WHITE: Thank you, Mr. Couch.

COUNCILMEMBER COCHRAN: Chair.

CHAIR WHITE: Yes, Ms. Cochran.

COUNCILMEMBER COCHRAN: Chair, thank you. And yea, and that was the reasoning I had doubts the first time around. I, as people know my feelings about STR's, TVR's, what have you. But, in this particular area, it's a very secludedly built sort of contained, I guess development, and these types of uses are happening. And, so the, as Mr. Couch said, the association is in favor.

And so, and it only, the bill itself only reflects properties such as these, from 1981 and prior. So from here on out, it's not like going to allow a free for all for every other similarly built projects to be included in this. So, that's where I gain my support, making sure that it's strictly, only addresses that particular development at this time. Thank you, Chair.



Housing and Land Enterprise of Maui, dba Na Hale O Maui was created as a grass roots organization that became a nonprofit 501(c) 3 entity *"To secure and preserve a permanent supply of affordable housing alternatives for low and moderate income households in Maui County."* We support all efforts to develop affordable housing in Maui County.

The Na Hale O Maui Community Land Trust (CLT) model is based on a 99-year sustainable ground lease; renewable for an additional 99-year term. The home can be inherited by children or repurchased by NHOM and sold to an income-qualified family. CLT homes help families build and accumulate wealth. They may share up to approximately 25 – 50% of any appreciation. To date, two homeowners received more proceeds under the 2-step resale formula than they originally invested in their home. NHOM updates and rehabilitates the homes before selling to a new income-qualified family at an affordable price. This reassures us that public funds invested in a CLT home today will act as a kind of perpetual 'endowment' of Community Land Trust affordable housing, generation after generation, buyer after buyer.

We respectfully request your support to further Na Hale O Maui's program and contribute to Maui County's goal of delivering affordable housing solutions. Your favorable approval of Bill 96 (2016,) awarding \$660,000 from the Affordable Housing Fund, will assist Na Hale O Maui with the vertical construction of Community Land Trust homes in the Kahoma workforce housing subdivision in Lahaina. This grant will be a catalyst, empowering Na Hale O Maui to deliver 12 new affordable homes in perpetuity for income-qualified families who work and/or live on the West Side.

Mahalo for you unwavering support of affordable housing and for Na Hale O Maui's CLT model that provides affordability in perpetuity.

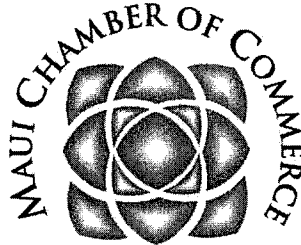
