Chair and Members:

Your Committee of the Whole, having met on November 18, 2016, makes reference to County Communication 15-6, from Councilmember Mike White, relating to litigation matters.

By correspondence dated November 7, 2016, the Department of the Corporation Counsel requested consideration of the possible settlement of The Matter of the Tax Appeal of Kaheawa Wind Power II, LLC, Tax Appeal 13-1-0313. Attached to the request is a proposed resolution, entitled "AUTHORIZING SETTLEMENT OF THE MATTER OF THE TAX APPEAL OF KAHEAWA WIND POWER II, LLC, TAX APPEAL NO. 13-1-0313," and a copy of the Notice of Appeal. The purpose of the proposed resolution is to authorize the Department to settle the tax appeal.

Your Committee notes the Notice of Appeal by Kaheawa Wind Power II, LLC, alleges the County of Maui improperly assessed the value of its real property located at 3000 Honoapiilani Highway for tax year 2013.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the case. He said the tax appeal involves Phase 2 of the wind farm above Maalaea.

Because the case involves ongoing litigation, the Deputy requested the opportunity to convene an executive meeting.
