THE REGULAR MEETING OF THE COUNCIL OF THE COUNTY OF MAUI, STATE OF HAWAII, WAS HELD IN THE COUNCIL CHAMBER, KALANA O MAUI BUILDING, WAILUKU, HAWAII, ON FRIDAY, NOVEMBER 4, 2016, BEGINNING AT 9:02 A.M., WITH CHAIR MICHAEL B. WHITE PRESIDING.

# **CEREMONIAL RESOLUTIONS**

RESOLUTION NO. 16-148

CHAIR WHITE: Mr. Victorino.

COUNCILMEMBER VICTORINO: Thank you, Mr. Chair.

COUNCILMEMBER VICTORINO: Thank you, Mr. Chair. May I ask the Clerk to have the resolution read in its entirely please?

CHAIR WHITE: Thank you, Mr. Clerk.

COUNCILMEMBER VICTORINO: Thank you, Mr., Mr. Chair. You know, today, again, we recognized another great leader in Maui County's history. The distinguished services, as you can see here, extends throughout his life, especially his adult life. He also served in a time when America was in great straits and had great bias against American-Japanese ancestry. But, he came as a little man, and everyone knew Mr. Ueoka wasn't a very big man, but he had a big heart, and he had a big, big desire to make Maui County a better place for all of us.

I had the good fortune through the years to have worked with Mr. Ueoka, not only as part of the School Advisory Council, but on the Board of Education. He was a mentor. Whenever I needed help, advice, he was always open to stopping at his office in Wells Street right down here, and talking stories, and trying to give me some ideas on what I would have to endeavor in on the Board of Education, as well as the School Advisory Council.

He also was a very good family friend. He and his son, Ladd, and the rest of the family, was always a part of my family for legal matters, in friendship, and in other areas. But, he served this community, as well as my family, in so many ways that it would take the better part of this meeting to cover all the various areas for which he and his family was a part of here in Maui County. Another great leader has been lost, but not forgotten. Another great leader that helped form and shape what Maui County is all about today, and where we can go and look forward to tomorrow.

So it's, it's really with great honor that I'm able to bring this resolution forward. I know many in this room have had connections, and workings with the late Meyer Ueoka. But, I think the best way I can sum it up; his stature may have been small, but he was a giant man that casted a giant shadow. Like so many other great leaders of this community, left us in a better place. Left it better than they got it, so that we can continue that mantra; making Maui No Ka Oi.

I want to thank the Ueoka family for allowing me the opportunity to bring forth this resolution. Unfortunately, Mr. Chair, none of the family was able to attend today. However, I will make sure I personally take it to Mrs. Ueoka. They live right up here at Sandhills, and I will drop it off with your permission.

And, finally I'll say God bless you, we'll miss you. But, we will never forget what you have done to make Maui, and Maui County, and this State, a better place. Thank you, Mr. Chair.

CHAIR WHITE: Thank you, Mr. Victorino.

COUNCILMEMBER CARROLL: Thank you, Chair. I knew Meyer a long time, and we did things together when he was on the Board of Education. He even came to Hana and worked with us, and School Advisory Council, and other things I was involved with, and other things in the community too. But the thing I remember about him most is he was fun. He was fun to be with. He had a sense of humor. And it was really, really lucky for me to have been his friend.

If I say anymore, I'm going to start choking up. So I will just say that we really miss him. He did so much for the community. I could spend some time over here telling you things he did that I doubt that people know about. But, he was really, really a terrific man. Aloha, Meyer.

CHAIR WHITE: Thank you, Mr. Carroll.

Mr. Guzman.

VICE-CHAIR GUZMAN: Thank you, Chair. I think they, at this point, we have to remember what Meyer Ueoka left behind, and especially in the legal profession. Most of the prominent attorneys had their beginnings and starts with the Ueoka firm.

And I had the great privilege of having a case with Meyer, and when he was age 86, and that, it was in Circuit Court. And, that case took about a year and a half. And going up against Meyer, you would think it would be a person that would have been a little slow on the draw, a little bit behind in his legal efficiencies. But, he litigated it well.

And I thought that he's going to, his thought processes when, when it comes to different type of legal theories was extraordinary. And so, I really appreciated that and I appreciated the fact that when the case was finished, we became very good friends. And I will always remember a lot of his stories that he gave me when the case is, was finished, and we laughed. So, I think he's one of those legal profession, professionals that will be very much missed, both within the bar as well as the community. So, thank you.

CHAIR WHITE: Thank you, Mr. Guzman.

Any further discussion, Members?

I'll just say, I didn't have the honor of working with him, but I met him on many occasions. But, what I'll remember of him is seeing him walking up and down Wells Street, and always having, whenever he engaged anyone, just had a big warm smile. And, and I agree with Mr. Victorino that we've, we've lost a giant in Maui community. And he'll be missed, but certainly not forgotten.

Ms. Cochran.

COUNCILMEMBER COCHRAN: Thank you, Chair. And this, I know, I've heard a lot about him, and actually my mom has done a lot of business through Meyer Ueoka, and as a child going there to his building. So, I didn't really, you know, know what the business was, was, but my mom has always spoken highly of him. So my mom is at the age of 91 today. And I'm sure she would, if she was here today, she would be having some good words to say about him. So on behalf of her, and knowing that he

helped my mom in her business endeavors throughout the years, that she sends her condolences to the family, and the thanks to the work that he did with her.

Mr. Chair, we have two individuals who have signed up to provide testimony in the chamber. The first individual to provide testimony is Rosemary Robbins, who will be testifying on Committee Report 16-176, to be followed by Sheri Thorson.

# PRESENTATION OF WRITTEN OR ORAL TESTIMONY

## MS. ROSEMARY ROBBINS (testifying on Committee Report 16-176):

Good morning, everybody. I didn't know Mr. Ueoka. I gather that heaven is the richer for his being there. So, amen to that.

Would like to testify today. This is on page 4 of our agenda. And this has to do with, actually there's a whole pile sort of referrals galore down here today, which should give us great hope. I read the materials that back this up and the promises of what's to come are well laid out in that. So, the work that has been done to that, to this point in time is something that I find very encouraging.

Specifics, okay, so on page 4, when we look down at item number 5, a matter of relating to prioritizing County development of off-site infrastructure, especially water - where have we heard that before — sewer, and roadway improvements, to support housing and make it more affordable to reducing some of the costs that are involved at this point. So, water, got to do something about it. We've been hearing about it for years. Now, it's mapped out in here about some timeframes and some of the requirements to pull that off. So hooray.

Also, under that 5, I've got circled on my agenda, item 5, referral the matter of "one-stop-shop" at the new County service center, wherever that's going to be, someplace convenient I hope, central, for processing permits to your Policy and Intergovernmental Affairs Committee.

When I read through the materials, it talked about the situation of permit purgatory, was the term that they used in there. I've never applied for a permit, but apparently it has been a situation that has a glimpse of hope if it's purgatory and not hell. But you don't get to purgatory without having left some stuff undone as I understand. So, hooray for that. For all of you people who are waiting and have been waiting for too long for permits, take hope.

Also, on the same page, referring items that are lands to be used, hopefully, for lands that are not being used now to be applied to the affordable housing situation. And there's material in there from the State; from other states, California, predominately in there; also from other counties. So, comprehensive. And, and I'm just really appreciative of what went into making all of this happen.

And I would just like to close with the thought of, you know, when we talk about, as an educator, I, I bring this up with my children a lot, about the "w's". Anybody, little kids will say oh yeah that's that who, what, what's the rest of it, what's the rest of it? Yeah, and the rest of the kids will fill in for them.

My point is to do that the other way around. Why? For the well-being of the folks in Maui. What? Anything that we can do, we've got a lot of talent in here, let's use it. Use it within our people recruiting other folks to help. When? We're already playing catch-up ball, let's hasten that. The where. Remember we're a three county, four island setup here on Maui, in the middle of the Pacific. That's an advantage in some cases, and an extra challenge in others. And the why. Because it's the right thing to do. Thank you.

CHAIR WHITE: Thank you, Ms. Robbins.

Members, any need for clarification? Seeing none, thank you for being here this morning.

MS. ROBBINS: You're welcome.

CHAIR WHITE: Mr. Clerk.

COUNTY CLERK: Mr. Chair, the next individual signed up to testify is Sheri Thorson, testifying on Committee Report 16-174, to be followed by Cassandra Abdul.

# MS. SHERI THORSON (testifying on Committee Report 16-174):

Hello. I came here this morning to thank all the Councilmembers for--

COUNCILMEMBER VICTORINO: Can you introduce yourself? Chair.

CHAIR WHITE: If you could mention your name for the record please.

MS. THORSON: Oh, I'm sorry.

CHAIR WHITE: No problem.

MS. THORSON: Sheri Thorson.

CHAIR WHITE: Thank you.

MS. THORSON: And I came here this morning to thank all the Councilmembers for their time, and Elle Cochran for introducing the ordinance. And, just for everyone's consideration in making Baby Beach safer for all of the children on Maui, and everyone that goes to Baby Beach.

Do I need to explain what, I think everyone here knows what the ordinance is about; parking on one-side of the street, so there isn't a problem with safety vehicles and children darting in and out.

CHAIR WHITE: You, you have time to explain if you feel you need to.

MS. THORSON: Well, I think everyone knows that. But, it can be a little dangerous down there when both sides of the street are parked on, because fire trucks cannot get down, and other vehicles have to stop and then all the traffic backs up and children darting around.

Last Sunday, when we came back from the Peter Pan play, and my granddaughters got out of the car and we're walking behind the car in the driveway, a car pulled in to let another car pass and she was standing right there. It was really frightening, because when there's cars parked on both sides of the street.

So, I just want to thank everyone for their consideration in making it safer. Thank you.

CHAIR WHITE: Thank you for your testimony.

MS. THORSON: Thank you.

CHAIR WHITE: Hold on just a moment.

Ms. Cochran.

COUNCILMEMBER COCHRAN: Sorry. Thank you, and good morning. Thank you for being here. And so just to, it's in regards to Kealakai Place in Paia, you're speaking about?

MS. THORSON: Yes, I'm sorry.

COUNCILMEMBER COCHRAN: Okay.

MS. THORSON: Kealakai and Baby Beach, that goes down to Baby Beach and Baby Beach parking lot.

COUNCILMEMBER COCHRAN: Right. Okay, very good. Thank you for being here this morning.

MS. THORSON: Thank you. Thank you.

CHAIR WHITE: Thank you.

Members, any other need for clarification?

Mr. Clerk, proceed.

COUNTY CLERK: Next testifier is Cassandra Abdul, Executive Director, testifying on Committee Report 16-176, on behalf of Na Hale O Maui.

# MS. CASSANDRA ABDUL (testifying on Committee Report 16-176):

Good morning. Cassandra Abdul, Executive Director, Na Hale O Maui. Here I am again. We are very pleased to see the timely referrals from the Planning Committee, that are the result of the Temporary Investigative Group, relating to increasing

affordable housing in Maui County. And we look forward to further discussions in the various Committees.

I was in a little bit of a mood this morning when I was writing this. And if only we lived on the Good Ship Enterprise and Captain Picard could just say make it so, and it would be so. Unfortunately, we live on earth here in Maui County. While deliberating the many merits of the referrals, I hope the Committees will keep in mind an old adage that I learned through scouting, and that's KISS - Keep it Simple, although I added silly, although that's not the way I actually learned it with the second "s".

Complexity really is not our friend. Keeping the resolution of these nine important issues simple will sharply increase the likelihood of success. The resulting bills will be clear and easy to understand while they are discussed and debated. Please listen and be willing to consider what you hear with an open mind, especially department personnel who are the experts with the experience and history to know the challenges of implementing and enforcing regulations with limited resources.

The Scouts taught me that keeping it simple is the best way to go. Consider what happens with the IRS regulations. Nobody on earth seems to understand that. And that to me is the ultimate complexity.

So, let's keep the big picture in sight. We desperately need more housing in Maui County. The upward pressure on home prices are caused by many things including the low supply of housing coupled with the high current and pent-up demand. Adding more houses can slow down and reverse this unrelenting increase in the cost to rent and own homes over time.

Thank you for all the work you do on behalf of the people of Maui. We ask that the various recommendations from the Planning Committee be referred to the appropriate committees, and that the committees work hard to keep it simple. Aloha.

MOVE TO ADOPT THE RECOMMENDATIONS IN COMMITTEE REPORT 16-172.

#### COUNCILMEMBER COCHRAN:

MR. CHAIR, I SECOND THE MOTION.

CHAIR WHITE: We have a motion from Mr. Guzman, and a second from Ms. Cochran.

Mr. Guzman.

VICE-CHAIR GUZMAN: Thank you, Chair. Your Committee met on October 18, 2016, to consider a proposed resolution to authorize the Mayor to submit an application to request the Governor to designate Molokai as an Enterprise Zone for 20 years.

Hawaii's Enterprise Zone Program was created by Act 78 (1986) and codified as Chapter 209E, of the HRS, to increase business activity, job retentions, and job creation in areas and industries where they are most needed and most appropriate

via tax and other incentives. The program was implemented in Maui County by the enactment of Chapter 3.80, of the Maui County Code, in 1994.

The program is a collaboration between the State and the County, with each providing some incentives, and allowing each county to select up to six areas meeting unemployment or income criteria for 20-year designations as an Enterprise Zone. Eligible businesses within an Enterprise Zone may apply for these incentives.

Pursuant to Section 3.80.030, of the Maui County Code, the Council may nominate an area in the County for designation as an Enterprise Zone by adopting a resolution and after a public hearing.

Your Committee notes that currently the Molokai Enterprise Zone designation will expire on December 31 of this year, 2016.

I respectfully request the Council for full support of this, of this recommendations. Thank you, Chair.

CHAIR WHITE: Thank you, Vice-Chair.

Any further discussion on this item?

Mr. Hokama.

COUNCILMEMBER HOKAMA: Chairman, thank you very much. First I want to thank Committee Chairman Guzman for bringing this forward. But, I'd also like to thank my colleague Ms. Crivello, who moved this forward through her communication regarding her island's situation, regarding economic development and job opportunities for their residents.

I'm in full support of what Mr. Guzman is recommending to us today. And coming from Lanai, Mr. Chairman, I have no problem, and I'm happy to state it today that I look forward to a public hearing on Molokai, to allow the Molokai people to speak directly to the Council regarding this item that I feel is a very advantageous tool should Molokai people embrace it and use it for their economic needs.

So I'm willing to state at this time, you know, whenever you're ready to schedule, Chairman, I'm happy to go to Molokai and allow them to give their comments on this important subject. Thank you.

COUNCILMEMBER COCHRAN: Thank you, Chair. Your Committee met on October 17, 2016, to discuss a revised proposed bill to prohibit parking on the west side of Kealakai Place in Paia, Maui, Hawaii, at all times and on the east side of Kealakai Place from 9:00 p.m. to 6:00 a.m.

Beach parking for Baby Beach is located at the end of Kealakai Place, but often overflows onto the street. So the Director of Public Works said the current parking situation prevents emergency vehicles from safely accessing Kealakai Place and, at times, prevents residents from accessing their driveways. With no parking

restrictions in place, residents are also concerned with overnight activities taking place at Baby Beach.

So, the proposed parking prohibitions would greatly help with ingress and egress, curb unwanted activity at the beach park during evening and overnight hours, and assist emergency personnel with access to the street as needed.

Your Committee notes Public Works Commission also, after hearing resident concerns, unanimously approved approval of the revised proposed bill at its meeting of August 24, 2016.

And, your Committee voted 6-0 to recommend passage of this revised proposed bill on first and final reading, reading, first reading and filing of communication.

And, I respectfully ask for consideration on this motion. Thank you, Chair.

CHAIR WHITE: Thank you, Ms. Cochran.



# DISCUSSION RELATING TO COUNTY COMMUNICATION NO. 16-273

VICE-CHAIR GUZMAN: Chair, may I ask the Budget Chair, Finance and Budget Chair Hokama if he would yield the referral to EAR Committee in reference to Communication 16-273? This is "A BILL FOR AN ORDINANCE RELATING TO CONCESSIONS AND SPONSORSHIPS IN COUNTY PARKS AND RECREATIONAL FACILITIES".

I had an opportunity to review the bill and the only provisions in there that I believe the Finance and Budget Committee would be interested in is the creation of the fund itself. There's provisions in there for adopting parks sponsorships and as well as, according to our resolution on Committees, the language that is designated for EAR referrals is the operations of the Department of Parks and Recreation's, including concessions, and the Office of Economic Development, including the oversight of any grants they administer. So, the wording is very clear where it says including concessions. And the bill itself is entitled under Chapter 13, so it's under the Parks ordinances.

So I would request that the Budget Chair, although it's, you know, he introduced the bill and it's a great bill, I, we've been waiting for that bill for quite some time. And it actually will enable a lot of the legislation that we've been waiting for from our revision of the previous Chapter. So, I would request that Mr. Hokama yield to EAR Committee, the referral.

CHAIR WHITE: Mr. Hokama.

COUNCILMEMBER HOKAMA: Chairman, thank you. And I understand Mr. Guzman's request. I, at this time, prefer not to. My intention was to expand the scope and view concessions for all County facilities and programs.

Yea, I've structured it intently on the proposal. And Mr. Guzman is right, I've been working on this for six years at minimum. I've always wondered why we chose not to do concessions since our sister-county, City and County of Honolulu, has been doing

it for decades and have been receiving millions from pouring rights and other opportunities that they've taken advantage of.

Our department needs to catchup, our departments, I should say, because this shouldn't only be about Parks. It should be any County facility that it makes sense for us to consider concessions, whether it be this County building, operational areas, whether it be a DMV, property tax, community centers, water billing areas. I think we need to look at this as a potential revenue source that will assist the General Fund to allow the Council to provide for things that we've been asked for. And one of our basic issues is the level of resources that we have available.

So for me, Chairman, I'm looking at this in a larger scope, bigger scope. I will be up front; we will not have time to work on it this term. So again, you know, we can make a call today, but it'll be part of the new Council's organization to decide how they want to move forward with the subject.

But, my thing was to expand it to view all facilities throughout the County, for Molokai, Lanai, and as well as for this island. Thank you.

CHAIR WHITE: Yea, the Chair's feeling is that we'll, as Mr. Hokama states, we'll have more opportunity to discuss where this item is heard. I, I do agree with Mr. Guzman that from a policy standpoint, the policy generation is appropriate in the EAR Committee. But since this is not coming up until next term, I think it's okay for it to be left with the current referral, and we can bring it up at a later date.

COUNCILMEMBER COUCH: Thank you, Mr. Chair. Just want to remind the Members that pursuant to our Resolution 15-5, anything that, issues involving the responsibilities of two or more standing committees should go to the Policy and Intergovernmental Affairs Committee. Just another thought.

CHAIR WHITE: Yea. Good point.

VICE-CHAIR GUZMAN: Chair.

CHAIR WHITE: Yes, Mr. Guzman.

VICE-CHAIR GUZMAN: The EAR Committee will yield to the BF Committee if that's the case. Thank you.

Dear Chair White:

We are pleased to see the timely referrals from the Planning Committee, that are the result of the Temporary Investigative Group (TIG,) related to increasing (affordable) housing in Maui County. We look forward to further discussion in the various Committees.

If only we lived on the good ship Enterprise and Captain Piccard could simply say "make it so," and it would be! However, we live in the real world in Maui County. While deliberating the many merits of the referrals, I hope the Committees will keep an old adage in mind: KISS - Keep it Simple (Silly – although that's not the way I learned it!) Complexity is not our friend.

Keeping the resolution of these nine important issues simple will sharply increase the likelihood of success. The resulting Bills will be clear and easy to understand while they are discussed and debated. Please listen and be willing to consider what you hear with an open mind, especially Department personnel who are the experts with the experience and history to know the challenges of implementing and enforcing regulations with limited resources.

The Scouts taught me that Keeping it Simple is the best way to go. [Consider the incredible complexity of IRS regulations in mind. It's rumored that they are so complex that no one understands them fully; not Congress, CPAs, tax payers, or IRS agents!] I hope that the Maui County Council can KISS!

Let's keep the big picture in sight: we desperately need more housing in Maui County. The upward pressure on homes prices are caused by many things including the low supply of housing coupled with the huge current and pent-up demand. Adding more homes can slow down and reverse this unrelenting increase in the cost to rent and own homes over time.

Thank you for the work you do on behalf of the people of Maui County. We ask that the various recommendations from the Planning Committee be referred to the appropriate committees, and that the Committees work hard to Keep it simple!

Good morning Council. Good Morning Chair.

OFFICE OF THE My name is Sydney Smith, I own, Maliko Estate Coffee Farm and Maliko Refreat vacation rental in Makawao.

I'm testifying today regarding the durational requirements for Short Term Rental Home Applications.

I recognize the intent behind the resolution. Everyone knows that there are not enough affordable homes here on Maui.

I would suggest a few simple changes to the bill.

Make it a 5-year residency requirement, rather than an ownership requirement of that property.

If someone has been a resident living here and paying taxes for 5 years they should be able to apply for a shortterm rental home permit.

Allow local people to transfer title to their children or family members without a penalty.

Requiring a landowner to own the property for five years will not necessarily lead to more affordable rentals. My own vacation rental houses were rented long term until I had long, protracted evictions in both houses. The repairs to those houses and the legal costs exceeded all the rents I had ever received from those houses. So we chose to leave them empty rather than risk that again. One house was empty for 10 years and one was empty for 20. If I was not able to rent my houses through the Short Term Rental Home and Special Use Permit system here in place in Maui County, those two houses would still be empty and 5 people would not have great paying jobs, that clean and maintain those houses and grounds for my guests.

Giving exemptions to houses of a million dollars or more will just lead to land owners adding amenities and additions to push the land value higher, removing more homes from the million and under category.

And do you really want to add yet another reason for people to go underground with their vacation rentals. There are so many reasons already.

There are great ideas in the TIG report that will result in more affordable rental homes being added to the inventory. I would add one more. Overhaul the landlord-tenant code as many jurisdictions have already done. This will lead to more empty houses being added to the inventory and may encourage others to build them.
