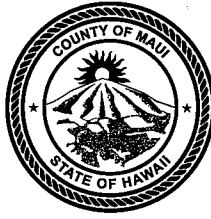

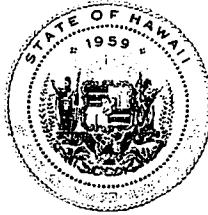

Subject: Transfer of Operation and Management of Phase 2 of the Central Maui Regional Sports Complex, Waikapu, Wailuku, Maui ("Complex")

Aloha Director Bueconsejo:

This is to notify you that the completion of Phase 2 of the Complex will occur on November 28, 2016, pursuant to Section II.B.9 of the Memorandum of Agreement Between the Board of Land and Natural Resources and the County of Maui and Its Department of Parks and Recreation ("MOA") executed on August 28, 2016. The MOA stated that the County of Maui, through the Department of Parks and Recreation ("Department"), will assume management of the subject phase upon its completion and release. As completion of Phase 2 of the Complex will occur on November 28, 2016, its release will occur concurrently or no later than December 5, 2016. The Department will be allowed to enter the Phase 2 area prior to the completion and release dates through notification to the Division of State Parks, DLNR ("State Parks").
