## SUBJECT: REQUESTS / QUESTIONS FROM THE APRIL 4, 2017 MEETING (PR-3)(BF-1)

The following is our Department's response to requests/questions from the April 4, 2017 meeting:

1. How many gates is the Blue Protection contract responsible for opening / closing at County-owned parks on Maui on a daily basis? Are these same services provided on Molokai and Lanai? Does the contract include clearing out parks or just opening / closing gates? What parks are included in the contract? Explain how the 5 expansion positions would fulfill the Blue Protection contract, to provide coverage in remote districts. (MW)

There is a total of 55 gates on Maui, one (1) on Molokai and none on Lanai. The contract includes doing a walk through of the entire park to clear it out prior to locking of gates. Attachment 1 includes all gates that are covered in the contract. The five (5) expansion positions will be able to cover the area that the contract covers.

2. If the request for five expansion Park Security Officer positions are approved in the FY 2018 Budget, what is the estimated timeline to fill the positions? Will funds for security services be needed during the interim period? If so, how much? (MW)

The estimated time for the hiring of five (5) expansion positions would be between three (3) to four (4) months. We would need funds for security services which would cost approximately \$98,781.60 for three (3) months service and \$131,708.80 for four (4) months service.

3. Provide the actual position title, SR level, and annual salary for PR-0228 Contracts Manager (page 12-6) of the Budget Details). (MW)

PR-0228, Contracts Clerk, SR-12C, \$34,296

4. Provide the actual position title, SR level, and annual salary for PR-0330 Assistant Park Permits Officer (page 12-7) of the Budget Details). (MW)

PR-0330, Special Events Specialist, SR-22C, \$50,772

5. Explain how the Department covered the cost overrun for premium pay for the Parks Administration Program in FY 2016 and FY 2017 as of February 28, 2017 (index 915017A on page 12-9 of the Budget Details). Why is the FY 2018 proposed budget not based on the actual expended?

For index 915017A for FY16 and FY17, as of February 28, 2017, savings in the "A" account covered cost overrun for premium pay.

There were many factors that caused the high cost of premiums for these periods. The Administrative Officer position was filled after nine (9) months of being vacant. The Administration Office had multiple operational processes and organizational systems that needed to be overhauled, including the training and technical support to transition more than 370 employees from manual time sheets to electronic time sheets.

There additionally were two retirements in the Administration Office and therefore additional overtime was expended to operate and then train their replacements during these time periods. Currently, all positions for the Administration Office are filled. The Administration Office is stable and does not require any additional manpower or overtime as the previous two years. This is why we did not base the request for premiums on the actual expended.

6. Explain how the Department covered the cost overrun for premium pay for the Parks Administration Program in FY 2016 and FY 2017 as of February 28, 2017 (index 915019A on page 12-9 of the Budget Details). Why is the FY 2018 proposed budget not based on the actual expended?

For index 915019A for FY16 and FY17, as of February 28, 2017, cost overrun for premium pay was covered by "A" account savings. Due to the current reorganization within the Permits and Enforcement Section, there have been several positions that were either filled at a lower rate than originally anticipated or were vacant for a period of time. For example, the Park Permits Officer was partially funded in both FY16 and FY17, but was unable to be filled during FY16. Since the position did not exist previously within the County of Maui civil service system, additional personnel steps needed to be taken in order to proceed with the recruitment. In addition, to finalize the recruitment for the Customer Relations Assistant HT, which has been corrected to a Parks Permit Support Clerk, and the Parks Permit Clerk II, similar measures needed to be taken. The additional premium pay incurred as a result of the shortage of manpower has been covered by these savings.

7. Provide the scope of the Blue Protection security service contract. (RH)

8. Explain how the Wells Park Master Plan was funded. (MW)

The Wells Park Master Plan was funded out of the Planning and Development Program for \$200,000 in FY16.

9. Explain the appropriation of \$200,000 for "funding to assist the golfing community..." as proposed (index 915017B, sub-object 6112 on page 12-10 of the Budget Details). (RH)
