COUNCILMEMBER CRIVELLO:

CHAIR WHITE: We have a motion from Ms. Sugimura, and a second from Ms. Crivello.

Ms. Sugimura.

COUNCILMEMBER SUGIMURA: Thank you. May I, may I request the Clerk to read the resolution in its entirety?

CHAIR WHITE: Certainly.

Mr. Clerk.

(The resolution was read in its entirety.)

CHAIR WHITE: Thank you, Mr. Clerk.

Ms. Sugimura.

COUNCILMEMBER SUGIMURA: At this time, I'd like to just say a few words about Seabury Hall, the coach, and this team. So, first I'd like to say that Seabury Hall is nestled in beautiful Haleakala, which is the home of our Council Chair who is actually presenting this resolution.

There are about 489 students, grades 6 - 12. And not only does Seabury Hall strive for college excellence, but they also provide a very well-rounded education and opportunities for its students. And I think today you are seeing the strength of its administration, and the strength of the students as they take these titles.

But I wanted to share with you a couple of things. I read the Maui News article and it talks about the strength of the team. And what's really cute is that, you may or may not know because Coach Paul Luuwai is wearing shoes, but his right toe nails are painted blue and his left toenails are painted red for the regatta. And it signifies the victories that the teams have won through the season. I think that's a real testament for how much he loves this sport and his teams.

I have a personal story about Coach Luuwai, which I think, to me expresses the integrity and strength of his convictions. I think, about 10 years ago, I was doing the milk carton regatta for Meadow Gold Dairies. And his team from King Kekaulike High School entered a regatta. Now, just know they're making this with two cases of milk cartons and with very stringent rules. And he may not remember this, but I went to talk to him before, and he asked me the rules. And one of the things you were not supposed to do is use glue; you're supposed to use tape. He said, "I used glue". I couldn't believe he confessed, right? So therefore, what happens when you do that is that he got actually points taken away, a lot of points taken away. When the race happened, his team would have been first.

But through the integrity of, of him as being a teacher and this person that he is for the students, I think I always remember this as one of my regatta most favorite stories. And here he is, taking this team to its glory. And I'm sure he used that same strength of, and integrity as he moved this team forward. So thank you very much, Chair.

CHAIR WHITE: Thank you, Ms. Sugimura.

COUNCILMEMBER ATAY: Chair, I want to first off congratulate all the young folks of Seabury Hall of this accomplishment of being the State of Hawaii's best.

But at this time, I would also recognize the accomplishments of your Coach Paul Luuwai. My relationship with Paul goes way back to when he was in high school and I was his coach in football. And then we carried on as competitive coaches in the club scene with Hawaiian Canoe Club and Kihei Canoe Club.

And Paul, we're part of the group that initiated in creating and making Hawaiian outrigger canoeing a high school sport in the State of Hawaii, as well as fielding the first teams here on Maui. He was instrumental in the growth of this sport, and I'm proud to see his accomplishments today, continuing to bring home the champions and championships to the island of Maui. So I say hulo hulo to Luuwai.

CHAIR WHITE: Thank you.

Ms. Crivello.

COUNCILMEMBER CRIVELLO: Thank you. On behalf of all of Maui County, and especially from our island of Molokai, I'd like to congratulate each and every one of you; students, canoe paddlers, your parents, your Seabury School, and of course your Coach Paul Luuwai.

You have demonstrated to us, of all in Hawaii nei, as well as from Maui, that your participation has demonstrated that no other culture in history has such a strong and intertwined existence with the ocean. Canoe paddling may not mean much to most people, but here in our beautiful Hawaii nei, canoeing is not only our State's official team sport, but a rich historical reminder.

So I want to thank you for your participation most of all, and for embracing the ingredient of canoe paddling that enriches our culture of Hawaii. Mahalo.

CHAIR WHITE: Thank you, Ms. Crivello.

VICE-CHAIR CARROLL: Thank you, Chair. We are so proud of you, your accomplishments and your ability to work together, and because that's what a team is, it's the ability to work together. And that's something that today and for the rest of your life that you'll take with you; that ability and what you've learned. Congratulations. CHAIR WHITE: Thank you, Mr. Carroll.

Ms. Cochran.

COUNCILMEMBER COCHRAN: Thank you, Chair. And yea, I echo all the positive, and sentiments, and accolades given to Seabury Hall. As an alumni of that school, I recall when we were really just a little blip on, not even a blip, because from seventh to twelfth grade, we had 150 students total. I had like seven in my seventh grade. And so to see it grow to where it is, and also putting the name and the school on the map big time of consecutive years in a row. I mean, just is really, really exciting and heartwarming, and just everything you can think of recalling back in the 70's to where, how far the school has come, and just the growth, and the you know, what they bring to, to Maui County.

So, I congratulate everyone and all the hard work, and dedication, commitment that goes into, you know, winning these, all these titles. So, my hats off, and thank you for putting Seabury Hall on the map. Mahalo.

CHAIR WHITE: Thank you, Ms. Cochran.

Any further discussion?

Mr. Guzman.

COUNCILMEMBER GUZMAN: Thank you, true, Chair. Thank you true, true Chair. But anyways, I would also like to echo the sentiments of my colleagues and congratulate Seabury Spartans.

And also Paul Luuwai for his dedication and sacrifices for the team. I have had the pleasure of working with his mother. I am sure a lot of her genes are in you, so it was no surprise to see you carry a team to its victory.

I also would like to thank the parents for all their sacrifices. I know it's been very difficult to take an athlete along its journey, along his or her journey, and waking up early in the morning and bringing to the practice, cooking the breakfasts and all that, and being the cheerleader with all the support and emotions. But so, I'd like to give my hats off to the parents for all their sacrifices. And athletes, please tell your parents thank you for every opportunity that they've given to you.

As the team is, you guys represent the Spartans, right? So, as Sparta became its power, it came into power by beating or defeating its rival city, Athens, in 431 BC. So, it's so amazing to see a small school rise from the ranks and go to States, and take

that victory. And the Spartan culture was based off of loyalty, discipline, and duty. And if you carry that, those principles in your athletic and your life itself, you'll be very successful.

So I'm, I'm very proud of each and every one of you. Mahalo and congratulations.

CHAIR WHITE: Ms. King.

COUNCILMEMBER KING: Thank you, Chair. Yea, I want to offer my congratulations to the team. And I also want to offer my congratulations to all those who fought to make this a sport, a real sport in the school system.

When I was on the school board, and I don't want to say how many decades ago that was, but you know, we didn't have this as an official sport. And the thing I really love about it is that it's non-violent, it's team building. And it's, these are the types of sports, I think, that truly represent Hawaii, and what we're trying to teach kids and you know, students of all levels in our sporting events in the school system.

So, congratulations on, on, on, on your win, and also a win that truly expresses what Hawaii is all about. We use that paddling in the canoe reference in so many of our, so many of our goal setting exercises. And, and so this kind of personifies the, the outcome of when you are truly paddling in the same canoe and going on the same direction. Thank you, Chair.

CHAIR WHITE: Thank you. You know, the credit that I see this many years of wins, really goes to Coach Luuwai. And, I really take my hat off to you for pulling, pulling out of each of these young athletes the best. And to have a small school from Maui cross the finish line three seconds ahead of Punahou, which is my alma mater, it's kind of sweet. And then to have the, I believe it was the girls come across the finish line a little more than two seconds ahead of Kamehameha. Punahou and Kamehameha have been powerhouses in many sports for many years. So, to see a little school on Haleakala beat those two powerhouses is really, really special for Maui. You guys have done an incredible job.

And as Mr. Guzman said, you've done it with bringing out the best in yourselves. You've done it with the support of your parents. And you know, parents play a really critical role in making sure that everything else in your life is orderly, so that you can focus on your school work and your sports. But it's that inner strength that your coach and your parents have, have worked on, and that you have honed that's really brought great honor to the school and great honor to Maui. And I want to thank you all for putting your shoulder to the wheel and, and pulling this off. It makes us all very proud and just kind of amazed that a small little school that can pull off; it's kind of the little engine that could. And so thank you for all you've done.

And with, I'm assuming there's no further discussion since everyone's spoken so far. So, please signify by saying "aye" if you're in favor of this motion.

COUNCILMEMBER SUGIMURA: Chair White, with your permission, I'd like to ask if we could ask the paddling teams and the Coach to come to the podium--

CHAIR WHITE: Certainly.

COUNCILMEMBER SUGIMURA: --so we can present them with leis and a copy of the resolution.

CHAIR WHITE: Thank you.

Please join us.

COACH PAUL LUUWAI: Is it proper for me to say a few words?

CHAIR WHITE: Absolutely.

COACH LUUWAI: Well, thank you so much for honoring our school and our team. Quiet. Yes, she's going to tease me at home. Anyway, I really appreciate you taking the time out in your busy schedule to honor our team and our accomplishments. It's been a, a long journey for them. Many of them paddled in the summertime for our club, and they put in a lot of dedication, work, blood, sweat, and tears like any other sport. I don't know if the kids really understand the significance of winning the way we did. I do.

But it's not only a high school accomplishment that they've achieved. It's like a lifetime accomplishment. No one can ever take away what they did. And I hope they can cherish the time together, and their camaraderie for their life, as I, I will.

And I am very honored and proud to be the Coach at Seabury Hall and at Hawaiian Canoe Club. I am very proud to be a father. And I truly believe and feel that they're all a part of my life, and my, my children too. For, as a Coach, gosh, sorry I'm so emotional.

CHAIR WHITE: You're getting us all--

COACH LUUWAI: As a coach--

CHAIR WHITE: --you're getting us all teary-eyed.

COACH LUUWAI: --you only dream about days like this. Excuse me?

CHAIR WHITE: You're getting us all teary-eyed.

COACH LUUWAI: Oh sorry. I was trying to be strong, but oh gosh, oh well. I'm a crybaby with this kind of stuff. But you know, as a coach, you only dream about days like this at a State championship. You never think it really would happen. But for them to do what they did was just phenomenal, you know. As a father, that was one of my most proudest moments.

The team has worked very hard. They've earned whatever they gotten. Like any sport, you want to do your best and perform at the highest level you can. And to do it on that day, in that race, in that atmosphere, on that stage, at that moment, was truly remarkable. And to win the way they did was awesome. So, thank you. Sorry.

CHAIR WHITE: Do any of the kids want to say something?

COACH LUUWAI: Captain.

MS. HILEI LUUWAI: I don't cry like him. Well, going into the race I didn't really think that we were going to win. But, we trained really hard this season. It was our best season

since I've been at Seabury. And, I think the reason why we won this year is because we spent a lot of time together bonding and having sleepovers. And I think we just have a stronger bond than the other teams because, well, we see each other every day and basically like every minute of the day. And it's really special because I'm doing the sport I love with the people I love. So, it was pretty awesome.

And yup, our Senior Night's tonight if you want to come; at Seabury Hall. Yea, we do a bunch of other sports too. I'm in softball, and the rest of our senior boys are doing surfing. So, we're pretty well-rounded in our sports. Thank you.

CHAIR WHITE: Thank you, Hiilei.

Congratulations again, and thank you for joining us this morning.

COACH LUUWAI: Thank you so much.

CHAIR WHITE: Okay, Mr. Clerk, may we proceed with the agenda.

## PRESENTATION OF WRITTEN OR ORAL TESTIMONY

## <u>MR. MIKE MORAN, KIHEI COMMUNITY ASSOCIATION, [testifying on County</u> <u>Communication Nos. 17-160, 17-164, and Bill Nos. 23 (2017), 24 (2017), 25 (2017),</u> <u>26 (2017), 27 (2017), and 40 (2017)]</u>:

Aloha, Chair and Councilmembers. Sometimes it's not good to be first. What an act to follow. And, everybody left.

Chair, first on, the first item 17-160, I would just like to speak as an individual. It's not part of our association. And that 17-160 is just to give my personal support to Aimee Anderson for Animal Control Board. And as you know, it shows on the agenda, the two other wahine that were on there withdrew. With respect to all it was like, here's two little chihuahuas coming up against this big pitbull, and they're saying no, I yield, I'll give it to Aimee. And I thank, you know, I thank her for taking this on as we all do, someone with her credentials to step up again and volunteer. So our support for Aimee Anderson for Animal Control Board.

Now moving on, and this is from the Kihei Community Association, item 164, 1, 2, and 3, for the Kihei Gym, the \$21.5 million budget amendment. About this time, ten years ago, we spoke to a now termed out Mike Victorino about no gym in Kihei. That year and every year, he spoke in favor, as we fully expect, he, were he here today, he would again, saying as he always did, why does every other place have a gym but not Kihei. Alas, today he would not, he would have no vote, but each of you do.

You each have somewhat divided duty and obligation in our opinion. You each represent all County residents, but yet you all individually speak for your residential area. But from either perspective, do not South Maui's keiki either based on revenue produced, percentage of population, or just fairness and pono deserve their own gym? Our duty as stated in our bylaws is specific to South Maui for advocacy.

So, each year, we see the Mayor's budget presented to you. And each year we see the CIP funds, by district, with continuing disappointment. South Maui is on the short end again in our opinion. For 2018 Fiscal Year, big winners are Central, with 30 percent; West Maui with 25 percent; then we see Kihei-Makena at 7.7 percent, which is about the same as smaller districts Paia, Haiku, and Upcountry, getting 7 percent each. And this is one of our worst allotments in recent history. We can go back in, in history and you'll see this, South Maui seems to be disproportionately allocated on CIP just about every year.

For this item for Parks and Rec, we mentioned this continuing regional distribution because we believe we heard Budget Hokama, Budget Chair Hokama, who is not here

right now, reference this balance or imbalance recently. Are regions fairly represented? We see this akin to the TAT that seeming all of Maui except perhaps two Legislators see as unjust.

So, is this one reason to approve this budget amendment to finally get this gym under construction? We believe it is one of many reasons to say yes. It's long past time for our South Maui youth.

I'll just continue on, Chair, for other items?

CHAIR WHITE: Yes.

MR. MORAN: Okay. And these will be much, much shorter. Moving on to South Maui CIP items Bill 23, 24, and 25, to replace the bridge culvert on South Kihei Road at Waiakoa Gulch, as well as Bills 26 and 27, for the Kihei Pump Station 16. We ask you to please approve these to help at least maintain our infrastructure.

And finally, the last item is Bill 40, to add a new category to the Planning Commission. As frequent participants at the Maui Planning Commission, we believe adding this individual is the right thing to do for our community. Mahalo.

CHAIR WHITE: Thank you, Mr. Moran.

Members, any need for clarification of his testimony?

COUNCILMEMBER KING: This---

CHAIR WHITE: Yes, Ms. King.

COUNCILMEMBER KING: Thank you. I have a question actually for the testifier. Thank you for being here, Mike.

MR. MORAN: Thank you.

COUNCILMEMBER KING: And I'm going to leave it up to you to answer to Tina Wildberger for likening her to a chihuahua.

But, on the, on the gym, thank you for supporting that. I just had, I, I spoke with the Parks Director and there's a assessment fee total for Kihei of 1.4 million, which they intend to use as the contingency. And so I'm just wondering, do you, and I'm not coming from any point of pro versus anti, but I just wondered if the KCA has looked at that, and if you support that being used as a, for a contingency on the gym?

MR. MORAN: We have looked at it, you know, from the perspective of what we have. We're somewhat limited as an all-volunteer group. But it's to the point now that it seems year after year, every time it comes up, there's one more reason not to support it. And we're to the point, yes, our kids deserve this. We just see young athletes. What about the South Maui athletes? Where is their opportunity?

And if it has to take something like this, yes this seems like an astronomical amount of money to spend. You're already going in for \$20 million, and then to add another million and a half. But, what will happen if we don't do it now? The price will just go up. So that's kind of our attitude at this point. Yes, whatever it takes. It's only going to get more expensive. Eventually it's going to be done. So, that's our perspective, Councilmember King. And thank you for the question.

COUNCILMEMBER KING: Thank you, Mr. Moran.

And, Chair, I think maybe this is, maybe even a chance to challenge ourselves to get this done before the State finishes the high school. So, I, I want to also to express that I have been impressed when it comes to these CIP projects and individual projects that the folks, the, my fellow Councilmembers have been very expressive of support for the entire island. So I'm hopeful that we can get this passed today. Thank you.

MR. MORAN: Thank you, Kelly. And, Chair, quickly indulgence, I don't want to go off the agenda, but a few people had said to us, gee, how come you guys didn't go out and testify at the, on the budget at the regional hearing? And again, trying not to stray too much from the budget, but I brought up the allotment. Our challenge is most times Kihei is the first public hearing, and it's seemingly about a week after this huge document comes out. And we were to the point where we couldn't testify intelligently on it, we hadn't absorbed it yet. But, rest assured we will be back as the budget is going through, through the hearings here. Thank you.

CHAIR WHITE: Thank you, Mr. Moran.

COUNCILMEMBER KING: Chair, can I make one more comment? I'm sorry, but I, one of the, just following up on that comment because I had spoken to Mr. Moran about this earlier that, that the card that comes out that expresses our budget, you know, kind of overall budget and then has the dates of the budget hearings, comes out after the first, you know, came out this year after the first couple of budget hearings. So, those dates were on there, but it was after the fact. So, I want to, you know, just apologize for that and hope that we can in, and then all, you know, and personally take some responsibility for trying to get that out a little bit earlier, at least to the Kihei community; maybe not that card, but you know, the notice.

- CHAIR WHITE: Certainly. Any further need for clarification of Mr. Moran's testimony? Seeing none, thank you very much for being here this morning.
- MR. MORAN: I would just say on that, we were aware of the meeting, but yes, I agree with the concept. Most of the community members don't get it, you know. It's in the paper. We have it on our website, but they need that reminder. So, we agree with that concept. Thank you very much.
- CHAIR WHITE: Thank you.

Mr. Clerk.

DEPUTY COUNTY CLERK: The next person to testify is Rosemary Robbins, testifying on County Communications 17-155 and 17-156. Ms. Robbins is the last individual who has signed up to testify in the Council chamber.

#### MS. ROSEMARY ROBBINS (testifying on County Communication Nos. 17-155 and 17-156):

Good morning, everybody.

CHAIR WHITE: Good morning.

MS. ROBBINS: I would like to add my yea Seabury to that. When Councilwoman Cochran, this morning, mentioned the times there in the seventies, in addition to academics, I was teaching aquatics at Seabury in grade six campus currently. But at that time, that was the pool.

And, interestingly enough, when a number of those kids whose families had spent substantial finances in order to have them at Seabury were looking how can I get financial aid when they went off to college, a number of them heading over to, including the East Coast schools, showed up with an American Red Cross certification that said they had taken this at Seabury Hall. And my connections on the East Coast were saying that their admissions committees were saying we want them with us. So, Seabury and little Maui, at a significant altitude by contrast to the rest of the shoreline aquatics folks had really come through on that.

So, I got a chance to talk this morning with one of the stars that just left, and it was just wonderful to be able to see how far they've come. Hooray. Okay, so thank you.

On item 17-55 *[sic]*, that's the one about non-urbanized area transportation. Those of us who were at both the, let's see, first of all, there was the one that was in Pukalani and then last night, at the one in Paia, heard people say it's just not safe and it's not practical to not have transportation running up to Upcountry in a logical system. Instead of coming up to Upcountry and then having to go back down in order to get on another bus that was going to take them over to further eastward on there, they needed to have more and couldn't miss it. I mean, I hear it all the time and so I wanted to speak to that today.

I went and got, this is on page 2 of our agenda today, I went ahead and got County Communication No. 17-155, and read through it, and it was pretty discouraging. The first thing that was in there was a page 49. No identity of what at least 48 other pages were with this piece. So, this was the sum total, on the seventh floor, as far as that was concerned, first thing we would look at. So, I went over and got what it was from the Federal department, we spoken about that before here. These are Federal funds that come to the States who are competing with all the other States, District of Columbia, some of our other territories. And then the State is allowed to spread that money out as it sees fit. And, they're sometimes private sector outfits that apply for that money and get it, and not necessarily just the municipalities. So again, just like with water, that's what was happening here. So, I went and got a hold of this and went through it. And it's pretty discouraging. It's from 2014--

DEPUTY COUNTY CLERK: Four minutes.

MS. ROBBINS: -- and 2015. Yes, I'm not going to be speaking on that other one.

- CHAIR WHITE: Yea, we can, no we can, you can start speaking on the other one now. You've exhausted four minutes.
- MS. ROBBINS: Yea, I'm saying that that was an error when I wrote that in. So, my error. I'm not going to speak on anything else. Can I just say on this, in closing, I'd recommend that none of this be passed on first--
- CHAIR WHITE: You're, you're pushing the rules a bit, but I'll let you have a couple of concluding sentences.
- MS. ROBBINS: Okay, thank you. Please don't let any of that pass on first edition today. There's all sorts of stuff in here that doesn't add up. So, given the opportunity to go through the things and find out what's with page 49, I'm sure will be enlightening to you. So, thank you.

CHAIR WHITE: Thank you very much, Ms. Robbins, for sharing your thoughts this morning.

Members, any need for clarification?

COUNCILMEMBER ATAY: Chair.

CHAIR WHITE: Yes, Mr. Atay.

COUNCILMEMBER ATAY: Ms. Robbins, what you are saying that when you click on 17-155, for the County's side, there's not enough information, but yet, you had to go to the Federal, someplace in the Federal government side?

MS. ROBBINS: No. I don't click on anything. I don't use computers anymore.

COUNCILMEMBER ATAY: Oh, I'm sorry.

MS. ROBBINS: But that's okay. No, this was from the seventh floor hard copy. And so I went and read everything that was in the hard copy and the first page in there was page 49, didn't say of what. And, then as I went through all the rest of the pages affiliated with that, I mean, one was a packet of 11 sheets, both sides. Another one was 14 sheets both sides. Going back 2014, 2015, 2016, we're dealing with the present and onto the future, and we've got faulty records.

COUNCILMEMBER HOKAMA: Chairman, again, this is what your Committee reviewed in multiple meetings. We are increasing the proviso amount for County costs by the September 2016 flood event on our, on Maui island by \$910,327 under Emergency Fund. Thank you, Chair.

COUNCILMEMBER COCHRAN: Chair. Thank you very much. And, yes we vetted and had many, many, many times of discussion on this item, and I still have questions. But of course, in very much favor of us appropriating monies appropriately to tackle emergency cases that, that do arise. So, I don't have much more to say. But, I am in opposition again. Thank you.

CHAIR WHITE: Thank you, Ms. Cochran.

COUNCILMEMBER KING: Chair.

CHAIR WHITE: Ms. King.

COUNCILMEMBER KING: Thank you, Chair. I concur with Ms. Cochran in, when, you know, I voted in favor of this in Committee because we were told we would get more complete information before it came to the Council meeting. We requested a, we had sort of a half of a vendor list of, I mean, the half complete vendor list. We had a vendor list with names, no descriptions of what the, the vendors did, codes that we asked to be deciphered, you know, in words.

(Councilmember Guzman returned to the meeting at 10:12 a.m.)

COUNCILMEMBER KING: And then they were also going to give us a list of which of those items from the first five something million, and the nine hundred and ten thousand plus that they're asking for, which of those were actual emergencies to be reimbursed by FEMA. So, that information has not been forthcoming yet. I did speak to the Budget Director, she was waiting to, to get those, the rest of the information. So, I don't think it's complete.

I'm not comfortable that, you know, I think, I think while expenses have to be covered, if they're coming out of the emergency funds, they need to be true emergency expenditures. And I'm not really convinced that those, all that money expended was on true emergency work.

So, I'm, I, I, I'm not comfortable with voting in favor of this at this time. And, and I, we still await the information that we requested in the, in Committee. Thank you.

CHAIR WHITE: Thank you, Ms. King.

Any further discussion?

Mr. Guzman.

COUNCILMEMBER GUZMAN: Thank you, Chair. Like my other two colleagues, well specifically Ms. King, I, I believe I and herself voted in reservation, but passed it out of Committee on condition that the Budget Director would provide, I believe, some object code definitions, as well as some specific clarifications and descriptions. And, I was assured by the Budget Director on the floor that that would occur prior to it being heard on the first reading. It has not. So, I, I gave them the benefit of the doubt.

So, I, at this point, I cannot support it. However, I would like to move for a deferral until that, I guess that material comes up or is disclosed.

COUNCILMEMBER CRIVELLO: Thank you, Chair. I'd like to refer the Members to the correspondence dated March 30, 2017, from the Planning Director, which Members should have a copy of.

The Planning Director noted that this proposed amendment would remove a possible inconsistency with the prohibition in Code Section 16.13.150.C.

As stated, in the Planning Director's correspondence, the bill's proposed new language for Section 16.13.020.A, Maui County Code, is intended to clarify that commercial signs have to be displayed on the property on which the commercial activity takes place, consistent with the existing prohibition in Section 16.13.150.C. However, we have since recognized that the new language could be read to have the opposite effect. For that reason, I am asking that this language be removed.

Thank you, Chair.

CHAIR WHITE: Thank you, Ms. Crivello.

COUNCILMEMBER COCHRAN: Sorry. Chair.

CHAIR WHITE: Ms. Cochran.

Ms. Crivello.

COUNCILMEMBER CRIVELLO: Thank you, Chair. I, I'm going to request for Director Sandy Baz to do a little clarification as to where exactly this amendment is addressed. It's in 17-62, which I requested for us to move it to 17-53. So, if you'll clarify it for us.

CHAIR WHITE: Mr. Baz.

DIRECTOR OF COUNCIL SERVICES: Thank you, Mr. Chair, and Member Crivello. Yes, so the amendment to Chapter 16.13, the bill that's in front of you in County Communication 17-53, excuse me, Committee Report 17-53, is in County Communication 17-162. So, if you refer back in Granicus to that County Communication, you'll see the Amendment Summary Form and the attached resolution.

The letter that she was referring to is a letter from the Planning Department, which was attached to the Committee item itself, okay.

CHAIR WHITE: Thank you.

Ms. Crivello.

COUNCILMEMBER CRIVELLO: Okay, so I'm going to restate. Mr. Chair, I'd like to refer the Members to the correspondence dated March 30, 2017, from the Planning Director, which Members should now have a copy of. The Planning Director noted that this proposed amendment would remove a possible inconsistency with the prohibition in Code Section 16.13,150.C.

As stated in the Planning Director's correspondence, the bill's proposed new language for Section 16.13.020.A, Maui County Code, is intended to clarify that commercial signs have to be displayed on the property on which the commercial activity takes place, consistent with the existing prohibition in Section 16.13.150.C. However, we have since recognized that the new language could be read to have the opposite effect. For that reason, I am asking that this language be removed.

Thank you, Chair.

CHAIR WHITE: Thank you, Ms. Crivello.

Members, any further discussion?

Mr. Guzman.

COUNCILMEMBER GUZMAN: Okay, I am a little bit confused, and so I'm sure the other Members are too. On the, the amended version of this bill that passed out of Committee, is, where is that language? Is there, so this is an attempt to amend the new language? Is that correct?

COUNCILMEMBER CRIVELLO: Yes.

CHAIR WHITE: It's to amend the committee, the language in the committee report.

COUNCILMEMBER GUZMAN: Yea, in the Committee. So, is there a Ramseyered version? Cause, is this the Ramseyer version that is attached to the March 30? Because I don't see the language that was passed out at Committee.

CHAIR WHITE: Mr. Baz.

DIRECTOR OF COUNCIL SERVICES: So, Mr. Chair, yea, County Communication 17-162, it has the, is a transmittal from Committee Chair Crivello and it's dated on March 31, 2017. And if you look at the Amendment Summary Form, it describes what she, the notes that she read. And on the third page of the amended resolution *[sic]* that she's proposing, you'll see the strikeout of that language that was added.

#### NO. <u>17-162</u> - <u>STACY CRIVELLO, CHAIR, HOUSING, HUMAN SERVICES, AND</u> <u>TRANSPORTATION COMMITTEE</u> (dated March 31, 2017)

Transmitting an amendment to the proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 16.13, MAUI COUNTY CODE, RELATING TO COMMERCIAL SIGNS".

COUNCILMEMBER GUZMAN: Okay. And that is in correspondence 17-62?

DIRECTOR OF COUNCIL SERVICES: 17-, yea, County Communication 17-162.

COUNCILMEMBER GUZMAN: Oh, 162. Okay, so that's where I need to refer to the language that was passed out of the Committee?

COUNCILMEMBER CRIVELLO: Yes.

DIRECTOR OF COUNCIL SERVICES: Well, the language that was, excuse me, Mr. Chair, the language that was passed out of Committee is Committee Report 17-53. So, if you want to read the original language that was passed out of Committee, you have to go to 17-53.

If you want to read the amended version with the Ramseyer section, it's County Communication 17-162.

COUNCILMEMBER GUZMAN: 162. Chair, can I have a recess to . . . that?

CHAIR WHITE: I'd be happy to give you a recess.

COUNCILMEMBER GUZMAN: Thank you.

(THE MEETING WAS RECESSED BY THE CHAIR AT 10:31 A.M., AND WAS RECONVENED AT 10:35 A.M., WITH ALL MEMBERS PRESENT, EXCEPT COUNCILMEMBER HOKAMA, EXCUSED.)

CHAIR WHITE: This meeting shall please come back to order.

Members, we are experiencing what it's like to have a paperless event, confused by Granicus having, you know, having documents in a couple of different areas. So, we will make an attempt to clarify things by having Ms. McLean explain the rationale for the changes that Ms. Crivello is requesting.

Ms. McLean.

DEPUTY PLANNING DIRECTOR MICHELE MCLEAN: Thank you, Chair. And, we do apologize to the Council for requesting that this, this last change be made. We are trying to avoid confusion, the commercial, not successfully.

The commercial sign ordinance already prohibits signs that advertise commercial activity on a different parcel. So, signs have to be on the parcel where the commercial activity is taking place. That's already in 16.13.

The language that's in front of you now, we thought it would be helpful to also put similar language in the beginning of the ordinance. However, there's a concern that that could be read to have the opposite effect. So, the language that we're asking to now be removed, which we had previously asked to be added. Because it would say

up front that this Chapter only applies to non-governmental signs that display messages on the property, someone could misinterpret that to mean that the Chapter doesn't regulate signs on other properties. And so, we tried to make that clarification upfront, but because it could be misread that way, the easiest thing to do was to just remove the language and let the existing language stand as it's written. Thank you, Chair.

CHAIR WHITE: Ms. King.

- COUNCILMEMBER KING: Thank you. Thank you for that explanation. So, I just wanted to clarify with Corp. Counsel that because it came unsigned that this is, you know, this is okay with our legal Counsel.
- CORPORATION COUNSEL PATRICK WONG: Chair. Thank you for the question. Because it's, in our opinion, a substantive change and it's already, it's up for first reading, typically, we don't want to sign a document that has a substantive change. And, but, given its first reading, and if this body approves the language, we are agreeable with the language and the proposed changes by the Department, and we will be signing the document prior to second and final reading.

COUNCILMEMBER KING: Okay. Thank you. Thank you, Chair.

CHAIR WHITE: Any further discussion, Members?

COUNCILMEMBER COCHRAN: Ms. Cochran.

COUNCILMEMBER COCHRAN: Thank you, Chair. I feel like I'm on The Voice, hit my green light. Yea, so, going paperless is great. I think my confusion was because it wasn't, I wasn't directed to what screens or what sections of Granicus I was to go to, to be referencing. Cause, once I was told I could find it all just fine, and understood what was going on. But that was, I think, the initial reason.

As for this, it was written originally to think right we're addressing issues. So how did it come about that, did, I don't know, another set of eyes in Corporation Counsel read through, or another set of eyes in Planning read through it and said, oh wait a minute, whoa this is completely going to have an opposite effect. Where, where did that occur? Cause, then my brain is thinking how many other things have we done that if that second set of eyes was there, we could have avoided, you know, negative unintended consequences. CHAIR WHITE: Ms. McLean.

DEPUTY PLANNING DIRECTOR: Thank you, Chair. It was another set of eyes in our Department. And I think it's, we did hesitate whether to make this request to Committee Chair Crivello, whether we felt that this change needed to be made because it's, it's kind of a reach to, to think that someone could read it the way that we, we're concerned about. So, it's, it could be read that way. I think it, it would be quite extreme for someone to interpret it that way. But, just to be safe, we thought it would be better to just have it taken out and let the original language stand, because the existing language really hasn't been problematic. It's not as if there's been a misunderstanding for the existing language, so just leaving it as it is, is the safer way to go.

CHAIR WHITE: Ms. Cochran, any further questions?

COUNCILMEMBER COCHRAN: Thank you. Thank you for that.

CHAIR WHITE: Members, any further discussion?

Mr. Guzman.

- COUNCILMEMBER GUZMAN: Yea, I'm still trying to, I've read this at least three times, the language. What, can you point out specifically where you feel it has the opposite effect, in the language, because it's non-governmental signs. Can we go through this step by step so I have a clear understanding where you're coming from?
- COUNCILMEMBER CRIVELLO: Chair. I'm sorry, Mr. Guzman. I'd like to defer this for now. I mean, there seems to be too many questions in regards to, and I guess confusion, and I apologize to the Members that we did not vet it out completely through the Committee. So, at this time, I would like to withdraw all what we--
- CHAIR WHITE: I think, if you don't mind, I think we're close to having the questions answered, but I'm, the Chair is comfortable making sure that everyone's comfortable before we move ahead. And if, if anyone is uncomfortable--

COUNCILMEMBER CRIVELLO: Is me.

CHAIR WHITE: --then I'm happy to, I'm happy to--

COUNCILMEMBER CRIVELLO: I am.

- CHAIR WHITE: No, but I, no, I understand your discomfort. But, I think what the Department is asking is, is reasonable and Mr. Guzman's asking a good question. And, if we can get this done today, I'd prefer getting it done rather than deferring.
  - So, Mr. Guzman, please proceed.
- COUNCILMEMBER GUZMAN: Yes. If you could show me exactly in the language where you perceive it as being in an opposite effect, because I, I'm having a hard time seeing that.
- DEPUTY PLANNING DIRECTOR: Because it says "This Chapter shall apply only to nongovernmental signs that display messages related to the use of, etc.", that means that the Chapter does not apply to--
- COUNCILMEMBER GUZMAN: Governmental?
- DEPUTY PLANNING DIRECTOR: --signs that don't meet, that don't meet that description, which could be interpreted to mean that, oh those signs aren't regulated, and therefore those signs are allowed.
- COUNCILMEMBER GUZMAN: That governmental signs are not regulated? Because you're saying--
- DEPUTY PLANNING DIRECTOR: It, it's the entire provision, "signs that display messages related to the use of, products sold on, or the sale or lease of, the property on which they are displayed". So, because the, the beginning of that sentence says this Chapter shall apply only to--
- COUNCILMEMBER GUZMAN: No, I, I saw it. Can I refer to Mr. Hopper? I think I can understand him much better on that.
- CHAIR WHITE: Mr. Hopper.
- DEPUTY CORPORATION COUNSEL MICHAEL HOPPER: I'll do my best. I think it's suggesting that the, that I think the Department's concern is that by saying that it applies "only to non-governmental signs that display messages related to the use of, products sold on, or the sale or lease of, the property on which they are displayed and that are located on private property". I think that by, if you had that language in there, there may be an implication that the Chapter does not apply or prohibit signs that advertise products sold off of the property; so, like billboards and things like that.

But, later on, in the actual Code already listed, there is already a prohibition on, on that. That's in Section 16.13.150.C, says "The following signs shall be prohibited: Signs which refer to activities or uses on another lot". So, those types of signs are prohibited, and I think Planning was concerned that the implication that if you say this Chapter only applies to non-governmental signs that display messages related to the use of, products sold on, or the sale and the lease of, property on which they are, are displayed, that could potentially be read as inconsistent with the other Section.

Keeping in mind, there's actually a State law, there's actually a State law that prohibits billboards anyway. So, you know, that's HRS 445-112. That actually prohibits billboards, you know, your common understanding of a billboard; a sign that advertise, advertises things for sale on a separate lot.

So, I mean, I think this is an abundance of caution to, to clarify that this Chapter, that the Chapter does prohibit those types of signs. State laws does it as well, but they didn't want to, they didn't want to have any implication here that this Chapter allowed those types of signs by being, you know, by saying this only regulates this type of sign. To suggest that it doesn't prohibit any other types of signs would be, would, that could potentially have bad implication, and I think the Department wanted to avoid that.

- COUNCILMEMBER GUZMAN: No, no, I, theoretically yea, you know, I guess in the court of law school, it would probably have some, some valid argument in front of a judge. But, yea, okay, I'll go with it. If it's an abundance of caution that's, that's fine.
- COUNCILMEMBER KING: Chair, to clarify. When we were reviewing this in Committee, you showed us a picture of a gas station that had a sign on it for a product that was obviously not made there, maybe not sold there, maybe it was. But, that, is that the type of thing that we're, so someone like, someone who puts those signs up could say well this, this Chapter doesn't apply to that sign because it's not about products that are made here, used here, sold here? Is it that type of billboard that you're trying, you're, you just want to make sure that everything is regulated under this if it's on that property, even if it's not a product that's sold there? Is that the intention?

CHAIR WHITE: Ms. McLean.

DEPUTY PLANNING DIRECTOR: That's correct. Some of the gas stations that they have, convenience stores that sell drinks and stuff. So, you will see energy drinks advertised on a gas pump, but they sell those inside so, that would be acceptable. But if they have an ad for some kind of event or product that's sold just down the road, but not on that property, then that would not be allowed. It's not allowed now, and it would continue not to be allowed.

- COUNCILMEMBER KING: Okay. So, that would be considered a billboard versus a sign? Is that what we're talking about? Is there like a description of what a billboard is versus a sign?
- DEPUTY PLANNING DIRECTOR: The County Code doesn't use the term billboard. Sign has a pretty broad definition, so if it conveys a commercial message, then that commercial message has to be on the property where that product or service is sold or provided.

COUNCILMEMBER KING: Okay, I think I understand why, what your intent is.

CHAIR WHITE: Any further discussion, Members? Ready to vote?

COUNCILMEMBER CRIVELLO: Ready to vote.

CHAIR WHITE: Okay. All those in favor of the motion please signify by saying "aye".

#### COUNCILMEMBER HOKAMA:

#### SECOND.

CHAIR WHITE: We have a motion from Mr. Carroll, and a second from Mr. Hokama.

Mr. Carroll.

VICE-CHAIR CARROLL: Thank you, Chair. At its meeting of March 17, 2017, your Committee considered a request to construct a helipad and operate a helistop for the property owner and guests of the Four Seasons Resort Lanai, Manele Bay.

Your Committee was advised that no tours will be provided from the helistop pad, which will be strictly for service to and from Manele.

Your Committee noted the use of the helipad is located away from cultural native Hawaiian bird nesting areas. Lighting will be directed downward to avoid disruption of wildlife.

And helistop pad operations will be prohibited from 7 p.m. to 7 a.m.

For 17-55, at its meeting on March 17, your Committee considered a conditional permit to allow two event sites: on the driving range, the 12<sup>th</sup> hole tee box, respectively, of the Challenge at Manele Golf Course.

The smaller event site will accommodate 25 to 100 guests, while the larger site will accommodate 75 to 300 guests. The events are primarily to be for corporate functions and hotel guests; however, residents will be allowed to use the event sites if coordinated through the Four Seasons Resort.

Committee noted that the events will end by 10 p.m. and coastal access to popular fishing spots will not be impacted by these events.

I ask for the Council's full support on these two items. Thank you, Chair.

CHAIR WHITE: Thank you, Mr. Carroll.

Discussion?

Mr. Hokama.

COUNCILMEMBER HOKAMA: Chairman, thank you. This morning I will speak with reservations on this two committee reports. For me, I have no problem with the intent and purpose of the two requests from Lanai Resorts or Pulama Lanai. And, I would say, I first want to thank Ms. McCrory and Pulama Lanai for understanding and be willing to accept a two-year conditional permit, okay.

For me, for those of you that don't understand our history, don't understand our history of development, the issues, problems, and requirements for land use authorization and entitlement, it is my disappointment that this Council chooses not to go what the District Member is recommending, as well as with the concurrence of the landowner, okay. We talk about conditional permits for the first time. And so I will express my disappointment that the district comments and the districts understand history is, is not really taken much in its consideration.

And so, you guys know how I feel about first time conditional permits request, but I will not, and the Committee understands my point, but I will go along with this with reservations because for us, it's tied to employment. We are in an unhealthy economic situation on the island, including social environment, okay. So, I need to be able to provide positive opportunities for our people who want to stay there, they have opportunities for work, and these things help the resorts provide that new opportunities of increased activities for our resident employees. But, I would continue to state my disappointment regarding the non-following of district recommendations with concurrence from the applicant. Thank you.

CHAIR WHITE: Thank you, Mr. Hokama.

Ms. Sugimura.

COUNCILMEMBER SUGIMURA: So, I have a question then. So, Mr. Hokama making a motion, or is he just expressing his--

CHAIR WHITE: He is expressing his reservations. I, I didn't hear a motion.

COUNCILMEMBER HOKAMA: There's no motion, Chairman.

CHAIR WHITE: Pardon.

COUNCILMEMBER HOKAMA: There is no motion.

- CHAIR WHITE: Yea, I agree with Mr. Hokama's sentiments to a degree. At the same time, the planning commission on Lanai is the body that approved the five-year term of the permit. So, we often support the--
- COUNCILMEMBER HOKAMA: Chairman.
- CHAIR WHITE: --the recommendations of the planning commissions whether it's on Molokai, or Maui, or Lanai.

Mr. Hokama.

COUNCILMEMBER HOKAMA: Well, then I would ask the Planning Department to be a little bit more consistent, okay. Cause I've seen a, we have a, one in Committee now for a one-year permit consideration? Okay, then we have five-years. Where is the bloody consistency, yea, for this Council and this, our departments on how we're going to approach additional permits, you know? Cause I will not do temporary spot zoning through a long-term permit on a first time request. They want zoning, ask for zoning, okay.

(Councilmember Crivello returned to the meeting at 10:56 a.m.)

COUNCILMEMBER HOKAMA: I understand why this is a conditional permit request, okay. They perform, I'm happy to give them five, ten year considerations of extension. Please understand why we do permits which is not, which authorizes, basically, a nonpermitted use in an area. That's why we're giving it a conditional permit. It's not granted in the normal zoning.

So, we got to make up our mind. Are we going to follow zoning? If not, are we just going to do everything by exemptions and permits? That's not the way for us to govern land use, because it relates back then, impact on taxation. And you know where we are in budget at this time, Members. So, thank you very much, Chairman.

CHAIR WHITE: Any further discussion, Members?

Mr. Carroll.

VICE-CHAIR CARROLL: Thank you, Chair. I'll take Mr. Hokama's comments to heart. And there is, I do not want to address them now or get into it now, but I assure Mr. Hokama that we'll be addressing them later. Thank you.

Katz, who is serving as the lead counsel on the matters relating to the arbitration involving the Hawaii Fire Fighters Association.

We did go into executive session. The, thereafter, the Deputy Corporation Counsel provided a brief overview of the reasons for the increased compensation. The Deputy also issued and indicated that during the course of the negotiations and in the arbitration, there was required from the employers to file and pursue a petition with the Hawaii Labors Relations Board.

Your Committee voted 8-0 for recommendation of the proposed resolution. And I respectfully request the Council's support for your Committee's recommendation. Thank you, Chair.


