SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2018 BUDGET

On behalf of the Office of Economic Development (OED), I am transmitting the attached proposed bill for the purpose of adding provisos under Appendix A, Part II of the Fiscal Year 2018 Budget pertaining to the Molokai Diversified Agricultural Revolving Loan Program.

OED is proposing to disburse \$214,748 as a grant to the University of Hawaii College of Tropical Agriculture and Human Resources (CTAHR) to help stimulate the growth of small business and diversified agriculture on the island of Moloka'i, of which CTAHR will reserve \$150,000 for cost reimbursements of up to \$5,000 to assist Moloka'i farmers in meeting federal and state food safety requirements which many farmers have difficulty fulfilling. The remaining funds, i.e., \$64,748 will enable CTAHR to provide training and training materials at no cost to farmers, process reimbursements for individual projects, and provide program reporting.

OED is also proposing that \$30,000 be allocated to cover the partial salary of its Economic Development Specialist on Moloka'i who will assist farmers in navigating the program and its financial requirements.

A BILL FOR AN ORDINANCE AMENDING APPENDIX A
OF THE FISCAL YEAR 2018 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2018,
MOLOKAI DIVERSIFIED AGRICULTURAL REVOLVING LOAN PROGRAM

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4456, Bill No. 65 (2017), Draft 1, as amended, "Fiscal Year 2018 Budget", Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2018, is hereby amended as it pertains to the Molokai Diversified Agricultural Revolving Loan Program, by adding provisos, to read as follows:
