**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2018 BUDGET**

On behalf of the Department of Public Works, I am transmitting the attached proposed bills for the purpose of adding a \$450,000 appropriation in the Fiscal Year 2018 Budget under the Bond Fund for a capital project entitled, South Maui Drainline Repairs and increasing the appropriation for the Central Maui Drainline Repairs capital project by \$3,990,000.

Emergency drainline and related repairs are desperately needed at the following South Maui and Central Maui locations where corrugated metal pipes have deteriorated so severely that holes have opened up the pipe. Sinkholes have occurred in all the proposed project areas. These projects must be completed to avoid worsening conditions and additional sinkhole risks and to ensure adequate drainage infrastructure and safe roadway conditions for the area.

- \$450,000 to replace approximately 475 feet of drainline at Wailea Alanui Drive in South Maui.
- \$350,000 to replace approximately 700 feet of drainline on Molokai Akau Street in Kahului from the intersection of Onehee Avenue to Pohaku Street. The project also involves reconstruction of affected driveways, sidewalk repairs, and necessary adjustments to other utilities.
- \$1,500,000 to replace approximately 2,300 feet of drainline on Pohaku Street in Kahului from the intersection of Molokai Akau Street to the outlet at the Kahului Community Center. The project also involves repairs to an existing outlet structure, necessary adjustments to other utilities, resurfacing of the affected lane at Pohaku Street, and reconstruction of speed humps.

- \$420,000 to replace approximately 450 feet of drainline at Hiahia Place within the Oceanview Estates subdivision. The project also involves necessary adjustments to other utilities and resurfacing of the affected lane at Hiahia Place.
- \$1,200,000 to replace approximately 1,500 feet of drainline at Wailupe Drive and Analio Street within the Waiehu Heights subdivision. The project also involves necessary adjustments to other utilities, replacement of storm drain manholes, resurfacing of Wailupe Drive and the affected lane of Analio Street, and reconstruction of speed humps.
- \$520,000 to replace approximately 360 feet of drainline at the intersection of Alamaha Street and Wakea Avenue in the Kahului Industrial area. Involves dewatering of the site and repairs to the existing sidewalk.

The Department of Public Works requests that this budget amendment be considered as soon as possible. I respectfully request that this matter be referred to the appropriate Council committee for expeditious review, discussion and appropriate action.

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4454, Bill No. 63 (2017), is amended by amending Section 1 to read as follows:

SECTION 1. Authorization of General Obligation Bonds. Pursuant to Chapter 47, Hawaii Revised Statutes, as amended, and particularly Part I thereof, there are hereby authorized to be issued and sold from time to time general obligation bonds of the County of Maui, State of Hawaii (the "County") in an aggregate principal amount not to exceed [~~\$44,305,000~~] \$48,745,000 (the "Bonds"), the proceeds derived from the sale of which shall be used to pay all or part of the cost of appropriations for the public improvements of the County described in Section 2 hereof.

SECTION 2. Disposition of Bond Proceeds. All or any portion of the proceeds derived from the sale of the Bonds or any notes issued in anticipation of the Bonds shall be used to pay all or part of the cost of any of the public improvements listed below in accordance with appropriations contained in the Fiscal Year 2018 Budget, including amendments and supplements thereto, duly approved by the Council of the County (the "Council") for the fiscal year ending June 30, 2018 (the "Fiscal Year 2018 Budget"); provided, however, that pursuant to Section 47-5, Hawaii Revised Statutes, the part of such proceeds which are in excess of the amounts required for the purposes for which the Bonds are initially issued from time to time, or which may not be applied to such purposes, or which the Council deems should not be applied to such purposes, may be applied to finance such other public improvements of the County as the Council shall, by ordinance approved by an affirmative vote of two-thirds of all of its members, determine; and provided further that the actual use and application of the proceeds of Bonds issued pursuant to this ordinance shall not in any way affect the validity or legality of such Bonds. No proceeds of the Bonds shall be applied to any public improvement listed in this section unless and until there shall be a valid appropriation of general obligation bond proceeds in effect for such public improvement. 
