On behalf of the Department of Parks and Recreation, I am transmitting the attached proposed bill for the purpose of decreasing the FY 2018 appropriation for the Administration Program and increasing the FY 2018 appropriation for the Recreation and Support Services Program.

The department is proposing to transfer a total of \$98,781 from the Administration Program, Category B for the following: \$24,799 to the Administration Program, Category A for overtime costs related to locking of park gates, \$18,982 to the Administration Program, Category C for the installation of surveillance and security systems at baseyards and pools to mitigate vandalism, and \$55,000 to the Recreation and Support Services Program, Category B for A/C maintenance, pest control, and water testing.
