A BILL FOR AN ORDINANCE TO AMEND SECTION 2.08.050, MAUI COUNTY CODE, PERTAINING TO LEGISLATIVE BRANCH ORGANIZATION

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 2.08.050, Maui County Code, is amended by

amending subsection A to read as follows:

"A. The council may provide for legislative personnel who are not members of the council services staff.

1. Council executive assistants shall serve under a council member, and shall have terms of employment that coincide with the term of the supervising council member unless sooner terminated by the council member having direct supervision or by a vote of council.

2. Council aides shall serve under the council chair, and shall have terms of employment that coincide with the term of the council <u>chair</u> unless sooner terminated <u>by the</u> council chair or by a vote of council."

SECTION 2. New material is underscored. In printing this bill, the County

Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.
