Chair and Members:

Your Parks, Recreation, Energy, and Legal Affairs Committee, having met on November 28, 2017, makes reference to County Communication 17-6, from Council Chair Mike White, relating to litigation matters.

By correspondence dated November 6, 2017, the Department of the Corporation Counsel requested consideration of the possible settlement of Claim 301547579300001 of Barbara Cabalo. Attached to the request is a proposed resolution, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 301547579300001 OF BARBARA CABALO," and a copy of the claim and related documents. The purpose of the proposed resolution is to authorize the Department to settle the claim for \$25,399.08.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

According to the proposed resolution, the claim against the County arose from damages to Barbara Cabalo's property at 877 Maikai Street, Makawao, Maui, Hawaii, resulting from a water main break on July 16, 2015.

A Deputy Corporation Counsel provided a brief overview of the case. The Deputy said the break in the water main resulted from normal wear and tear. It took about three hours for the water to be shut off, and by then, muddy water had entered Ms. Cabalo's garage and home. The Department provided a list of costs incurred by Ms. Cabalo.
