

AUTHORIZING ACCEPTANCE OF A DONATION TO THE  
COUNTY OF MAUI, DEPARTMENT OF PARKS AND RECREATION,  
MAINTENANCE DIVISION, FROM BEYOND PESTICIDES  
FOR SOIL ANALYSIS AND REVIEW OF CURRENT TURF  
MAINTENANCE PRACTICES, PURSUANT TO  
CHAPTER 3.56, MAUI COUNTY CODE

WHEREAS, the Department of Parks and Recreation desires to implement the best practices for economical and sustainable turf maintenance in the various County Parks; and

WHEREAS, a national, non-profit organization, Beyond Pesticides, has offered to conduct soil analysis at four diverse sites selected by the Department of Parks and Recreation in order to evaluate the microbial activity and soil composition at each site and recommend economically viable pesticide-free alternatives for turf maintenance; and

WHEREAS, the estimated value of the soil analysis and evaluation by Beyond Pesticides is approximately \$5,000.00; and

WHEREAS, Chapter 3.56, Maui County Code, authorizes the Council to accept gifts and donations on behalf of the County; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby expresses its appreciation and accepts the aforesaid donation on behalf of the County of Maui; and
2. That the Mayor, through the Department of Parks and Recreation, is hereby authorized to execute all necessary documents and fulfill

other requirements to comply with the soil analysis program discussed herein, including answering questions, providing soil samples for lab analysis, meeting with designated soil or site evaluation agents, or other related requirements in order to conduct the soil analysis; and

3. That certified copies of this Resolution be transmitted to the Mayor, the Director of Finance, and the Department of Parks and Recreation.
