A BILL FOR AN ORDINANCE AMENDING CHAPTERS 2.80B AND 2.90A, MAUI COUNTY CODE, RELATING TO THE KAHOOLAWE COMMUNITY PLAN

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

- SECTION 1. Purpose. The purpose of this ordinance is to remove the requirement of a Kahoolawe Community Plan.
- SECTION 2. Section 2.80B.070, Maui County Code, is amended by amending subsection C to read as follows:
 - "C. The following community plans are incorporated by reference and adopted pursuant to this chapter:
 - 1. Hana [Community Plan] <u>community plan</u> Ordinance No. 2347 (1994), as amended[;] .
 - 2. Paia-Haiku [Community Plan] <u>community plan</u> Ordinance No. 2415 (1995), as amended[;] <u>.</u>
 - [3. Kahoolawe Community Plan Ordinance No. 2413 (1995), as amended;
 - 4.] 3. West Maui [Community Plan] community plan Ordinance No. 2476 (1996), as amended[;].
 - [5.] <u>4.</u> Makawao-Pukalani-Kula [Community Plan] <u>community plan</u> Ordinance No. 2510 (1996), as amended[;]
 - [6.] <u>5.</u> Kihei-Makena [Community Plan] <u>community plan</u> Ordinance No. 2641 (1998), as amended[;] <u>.</u>
 - [7.] <u>6.</u> Lanai [Community Plan] <u>community plan Ordinance No. 4343 (2016)[;].</u>
 - [8.] 7. Molokai [Community Plan] community plan Ordinance No. 3022 (2001), as amended[; and] .
 - [9.] <u>8.</u> Wailuku-Kahului [Community Plan] <u>community</u> <u>plan</u> Ordinance No. 3061 (2002), as amended."
- SECTION 3. Section 2.80B.080, Maui County Code, is amended by amending subsection A to read as follows:

"A. Each of the County's [nine] <u>eight</u> community plans shall, to the extent practicable, be updated within ten years (decennially) of the respective plan's adoption. The decision as to the order of updating the [nine] <u>eight</u> community plans shall be decided by the council."

SECTION 4. Section 2.80B.080, Maui County Code, is amended by amending subsection B to read as follows:

"B. There shall be a community plan advisory committee for each community plan area set forth in section [2.80B.070.B. Except for the community plan advisory committee for the Kahoolawe community plan, each] 2.80B.070(C). Each community plan advisory committee shall consist of residents of the corresponding community plan area and shall hold all meetings in the corresponding community plan area."

SECTION 5. Section 2.90A.010, Maui County Code, is amended by amending the definition of "Community plan" to read as follows:

""Community plan" means the [nine] <u>eight</u> community plans for land uses and development within the County, as adopted by the council."

SECTION 6. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 7. This ordinance shall take effect upon its approval.
