## SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2018 BUDGET

On behalf of the Department of Parks and Recreation, I am transmitting the attached proposed bill for the purpose of decreasing Estimated Revenues, Charges for Current Services by \$355,000 and increasing Carryover/Savings Golf Fund by \$110,000 due to projected budget shortfall as a result of renovations which have closed a portion of the golf course and a decrease in the golf course concession monthly rental.

In addition to increasing Carryover/Savings Golf Fund by \$110,000, the shortfall will be absorbed by a combination of \$245,000 in salary and operational savings. A Certification of additional Revenues for Fiscal Year 2018 to certify the availability of Golf Fund Carryover/Savings is attached for your information.

The Fiscal Year 2019 Mayor's Proposed Budget includes all available Carryover/Savings available in the Golf Fund. Should the Council approve this amendment, \$110,000 will be required to be removed from the \$419,510 estimated in the proposed budget.

## A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2018 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF PARKS AND RECREATION, WAIEHU GOLF COURSE PROGRAM - GOLF FUND; TOTAL OPERATING APPROPRIATIONS; AND TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:
