BILL NO. 48 (2018)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.37, MAUI COUNTY
CODE, RELATING TO THE KAUNOA SENIOR SERVICES LEISURE PROGRAM
ACTIVITIES REVOLVING FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 3.37.010, Maui County Code, is amended to read as follows:

“3.37.010 Purpose. The Kaunoa [Senior Services Leisure Program Activities Revolving Fund] senior services leisure program activities revolving fund will enable Kaunoa [Senior Services] senior services to collect fees and voluntary contributions from participants to help recover the costs for certain special events, activities, on-going classes, and excursions.”

SECTION 2. Section 3.37.020, Maui County Code, is amended to read as follows:

“3.37.020 Fund established. There is hereby established and created a fund to be known as the “Kaunoa [Senior Services Leisure Program Activities Revolving Fund.]” senior services leisure program activities revolving fund. Fees and voluntary contributions collected from Kaunoa [Senior Services Leisure Program Activities] services leisure program activities shall be deposited in the fund.”

SECTION 3. Section 3.37.030, Maui County Code, is amended to read as follows:

“3.37.030 Administration. A. The director of finance shall establish a separate account to record all revenue credited to, and expenditures made from, the revolving fund.


B. Fees collected from Kaunoa senior services leisure program activities shall be used for the payment of costs associated

with Kaunoha senior services leisure program activities. Expenditures from the fund shall be through appropriations set forth in Appendix A.II. of the annual budget ordinance. [The fund shall not be used to pay for employee salaries.]”

SECTION 4. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or underscoring.

SECTION 5. This ordinance shall take effect on July 1, 2018.
