Chair and Members:

Your Parks, Recreation, Energy, and Legal Affairs Committee, having met on July 3, 2018, makes reference to County Communication 17-6, from Council Chair Mike White, relating to litigation matters.

By correspondence dated May 11, 2018, the Department of the Corporation Counsel requested consideration of the possible settlement of Claim 30178459821-0001 by Island Insurance Company, Limited, on behalf of its insured, George and Donna Brown. Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 30178459821-0001 OF ISLAND INSURANCE COMPANY, LTD., ON BEHALF OF GEORGE AND DONNA BROWN." The purpose of the proposed resolution is to authorize the Department to settle the case for \$8,603.10.

The Department also transmitted a copy of the claim and documentation relating to damages associated with the claim.

Your Committee notes the claim alleges damages to George and Donna Brown's vehicle resulting from a collision involving a County of Maui fire truck on May 10, 2017, in Lahaina, Hawaii.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the case. She said the fire truck was traveling on Front Street in Lahaina and made a turn onto Market Street for a medical emergency. As the truck made the

turn, the back end of the truck hit the driver side of the Browns' vehicle. The vehicle was declared a total loss by the Browns' insurer, Island Insurance Company, Limited, with a settlement value of \$8,603.10. The Browns have been paid on their claim by their insurer, who is seeking reimbursement by the County.

Your Committee voted 5-0 to recommend adoption of the proposed resolution. Committee Vice-Chair King and members Atay, Crivello, Sugimura, and White voted "aye." Committee Chair Guzman and members Carroll, Cochran, and Hokama were excused.

Your Parks, Recreation, Energy, and Legal Affairs Committee RECOMMENDS that Resolution \_\_\_\_\_\_, attached hereto, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 30178459821-0001 OF ISLAND INSURANCE COMPANY, LTD., ON BEHALF OF GEORGE AND DONNA BROWN," be ADOPTED.
