Chair and Members:

Your Parks, Recreation, Energy, and Legal Affairs Committee, having met on July 3, 2018, makes reference to County Communication 17-6, from Council Chair Mike White, relating to litigation matters.

By correspondence dated June 5, 2018, the Department of the Corporation Counsel requested consideration of the possible settlement of Paula Burns v. County of Maui, Disability Compensation Division Case 7-17-00866. Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT OF PAULA BURNS V. COUNTY OF MAUI, DISABILITY COMPENSATION DIVISION CASE NO. 7-17-00866." The purpose of the proposed resolution is to authorize the Department to settle the case.

Your Committee notes Section 3.16.020(A), Maui County Code, requires Council authorization for any settlement of a workers' compensation claim in excess of the authority granted by that provision.

A Deputy Corporation Counsel provided a brief overview of the case. He said the workers' compensation claim involves an employee of the Department of Parks and Recreation who injured her back while trying to lift a 50-pound box of toilet tissue in the storage room at the Eddie Tam Memorial Center. He said the injury occurred on December 12, 2016, and was witnessed by Ms. Burns' supervisor.

Because the case involves ongoing litigation and confidential medical information, the Deputy requested the opportunity to convene an executive meeting.
