Chair and Members:

Your Policy, Economic Development, and Agriculture Committee, having met on July 23, 2018, makes reference to County Communication 18-255, from the Mayor, transmitting the following:

- 1. A proposed resolution entitled "APPROVING THE APPOINTMENT OF WILLIAM SPENCE AS THE DIRECTOR OF THE DEPARTMENT OF HOUSING AND HUMAN CONCERNS." The purpose of the proposed resolution is to approve the appointment of William Spence as the Director of Housing and Human Concerns, pursuant to Sections 6-2(5) and 8-10.2 of the Revised Charter of the County of Maui (1983), as amended.
- 2. A proposed resolution entitled "APPROVING THE APPOINTMENT OF MICHELE MCLEAN AS THE DIRECTOR OF THE DEPARTMENT OF PLANNING." The purpose of the proposed resolution is to approve the appointment of Michele McLean as the Planning Director, pursuant to Sections 6-2(5) and 8-8.2 of the Revised Charter of the County of Maui (1983), as amended.

Your Committee considered the appointment of the Director of Housing and Human Concerns.

Pursuant to Section 8-10.2 of the Revised Charter of the County of Maui (1983), as amended ("Charter"), "the director of housing and human concerns shall be appointed by the mayor with the approval of the council." Further, pursuant to Section 6-2(5) of the Charter, the Mayor

shall appoint the Director of Housing and Human Concerns within 60 days after a vacancy is created. The deadline for Council approval is August 26, 2018, or the appointment will be deemed confirmed.

Your Committee notes the Charter requires that the Director of Housing and Human Concerns "shall have had a minimum of five years of experience in an administrative capacity, either in public service or private business, or both."

Your Committee interviewed Mr. Spence.

As Planning Director, Mr. Spence said he has always supported housing, particularly affordable housing. Although the term of his appointment will end in the next five months, he is excited for the opportunity to use his planning background to move projects forward.

Your Committee notes Mr. Spence has held the position of Planning Director since January 2011 and has been a member of the American Planning Association since 1987.

Your Committee further notes Mr. Spence possesses a Bachelor of Science degree in Urban and Regional Planning from California State Polytechnic at Pomona, School of Environmental Design.

Your Committee considered the appointment of the Planning Director.

Pursuant to Section 8-8.2 of the Charter, "the planning director shall be appointed by the mayor with the approval of the council." Further, pursuant to Section 6-2(5) of the Charter, the Mayor shall appoint the Planning Director within 60 days after a vacancy is created. The deadline for Council approval is August 26, 2018, or the appointment will be deemed confirmed.

Your Committee notes the Charter requires that the Planning Director "shall have had a minimum of five years of experience in the field of planning, at least three of which shall have been in an administrative capacity, either in public service or private business, or both."

Your Committee interviewed Ms. McLean.

Ms. McLean said her background as a Legislative Analyst served her well as an administrator and as a planner. She said there are a handful of planning initiatives she would like to see completed by the end of this term.

Your Committee notes Ms. McLean served as the Deputy Planning Director since 2011. In this capacity, she assisted with overseeing all operations of the Department comprised of five divisions, Administration, Long Range Planning, Current Planning, Zoning Administration & Enforcement, and Plan Implementation. According to her resume, Ms. McLean was previously employed as a Land Use Planner with Smith Development.

Your Committee further notes Ms. McLean possesses a Bachelor's degree in Political Science from Vassar College and a Master's degree in Business Administration from University of Phoenix.

Your Committee questioned the need to appoint individuals to these positions given the few months left in the term.

Your Committee acknowledged the importance for employees in the respective departments, and the general public, to rely on authority, instead of dealing with interim or acting figures.

Your Committee acknowledged Mr. Spence's and Ms. McLean's commitment to address the County's housing and planning needs, respectively, for the benefit of the community. Your Committee was
