Chair and Members:

Your Budget and Finance Committee, having met on July 24, 2018, makes reference to County Communication 18-247, from Councilmember Riki Hokama, relating to amendments to Appendix A, Grant Revenue – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year ("FY") 2019.

By correspondence dated July 11, 2018, the Budget Director transmitted a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANTS AND RESTRICTED USE REVENUES – SCHEDULE OF GRANTS AND RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS, OFFICE OF THE MAYOR (STATE OF HAWAII DEPARTMENT OF AGRICULTURE – KULA AGRICULTURAL PARK EXPANSION)."

The purpose of the proposed bill is to amend Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs, FY 2019 Budget, by amending the title of the grant from "State of Hawaii Department of Agriculture – Kula Agricultural Park Expansion" to "State of Hawaii – Upcountry Maui Agricultural Park, Maui Expansion." The funds are for land acquisition, engineering, irrigation infrastructure, ground and site improvements, equipment, and appurtenances for the park.

Your Committee notes \$1,100,000 in bond funds were appropriated for the Kula Agricultural Park Expansion in FY 2018. The County's appropriation is the required matching funds for the State of Hawaii grant.

Your Committee further notes the FY 2018 appropriation describes the project as a County purchase of approximately 869 acres of former

sugar cane land from Alexander & Baldwin in the Omaopio/Pulehu vicinity, including a 54-million-gallon reservoir. Following the acquisition, the County may conduct a first-phase engineering study to deliver a planning-level site layout for individual agricultural lots, and acquire irrigation pipes, meters, and power infrastructure. Additionally, the funds may be used for site work, infrastructure and road development, permitting requirements, a 20-year operational cost analysis and business plan, and other related requirements.

Your Committee noted the amendment to the grant is to reflect the same appropriation title as listed in the State's Budget bill.

Your Committee voted 7-0 to recommend passage of the proposed bill on first reading. Committee Chair Hokama and members Atay, Carroll, Cochran, Crivello, King, and Sugimura voted "aye." Committee Vice-Chair White and member Guzman were excused.

Your Committee is in receipt of a revised proposed bill, approved as to form and legality by the Department of the Corporation Counsel, incorporating a nonsubstantive revision.
