Your Budget and Finance Committee, having met on July 31, 2018, makes reference to the following:

Department of Water Supply Revenue Fund to the Bond Fund as of May 31, 2018.

Your Committee notes Section 18 of the General Budget Provisions allows for temporary transfers or loans from the General Fund to the Bond Fund not to exceed the amount of general obligation bonds or notes authorized but not issued. At any time, the aggregate amount of such transfers and loans that shall be unreimbursed shall not exceed \$55 million.

The Director of Finance said the County has the ability and the cash flow to allow for the transfers prior to the issuance of the bond. He said the County currently has authorized approximately \$79 million in bond funds, but only \$38 million has been expended to date.

The Director said the County could issue a general obligation bond in late September 2018 for approximately \$80 million. The General Fund would be replenished upon issuance of the bond.

He stated his Department is currently checking with the project managers on the anticipated expenditures for this coming year for all approved bond-funded projects. The information received from the project managers and the amount already expended will determine the actual amount of the bond issuance.

Your Committee deferred action on County Communication 18-249 pending further discussion.

Your Committee voted 6-0 to recommend filing of the communications. Committee Chair Hokama and members Atay, Carroll, Cochran, Crivello, and Sugimura voted "aye." Committee Vice-Chair White and members Guzman and King were excused.
