Chair and Members:

Your Budget and Finance Committee, having met on September 18, 2018, and October 2, 2018, makes reference to County Communication 18-310, from the Budget Director, transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES – SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2019, COUNTYWIDE SEWER CAPITAL IMPROVEMENT RESERVE FUND."

The purpose of the proposed bill is to amend Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds, Fiscal Year ("FY") 2019 Budget, Countywide Sewer Capital Improvement Reserve Fund ("Reserve Fund"), by adding a proviso for \$1,273,000 for the South Maui Recycled Water System Expansion project ("Project").

2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX C - CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, KIHEI-MAKENA COMMUNITY PLAN AREA, SOUTH MAUI RECYCLED WATER SYSTEM EXPANSION" ("Appendix C bill").

The purpose of the proposed bill is to amend the FY 2019 Budget, Appendix C, Capital Improvement Projects, by adding an appropriation of \$1,273,000 under the Department of

Environmental Management, Kihei-Makena Community Plan Area, for the Project; and a description of the Project.

The Budget Director said in FY 2018, \$2,750,000 from the Sewer Fund and \$3,750,000 from the State Revolving Loan Fund ("SRF") were appropriated for the Project, for a total appropriation of \$6,500,000. The appropriation is available through December 31, 2018.

He said the proposed amendment would appropriate \$1,273,000 from the Reserve Fund to cover the budgetary shortfall for the Project. The Budget Director said the Project qualifies under the parameters set forth for the use of the Reserve Fund. The proposed amendment utilizes approximately one-half of the amount transferred from the Sewer Fund to the Reserve Fund for FY 2019.

A representative from the Department of Environmental Management, Wastewater Reclamation Division, said the Project would expand the use of recycled water in South Maui. He said the additional one-million-gallon storage tank would be constructed on the same site as the existing tank.

He said current users empty the existing one-million-gallon storage tank twice per day during the summer months and once per day during the winter months. In order to maintain the existing users and accommodate any additional users, another tank is needed.

The representative noted an expansion of the reuse water system was approved in FY 2017. He said the lack of storage has resulted in customers having to wait until the additional tank is constructed and an ample supply of reuse water is available. He also said there are more than 40 customers of reuse water in South Maui.

Your Committee noted the lowest bid received for the Project is approximately 20 percent higher than the projected cost. Your Committee questioned whether the Project should be re-bid instead of moving forward with the current bid.

The representative said five bids were received for the Project. The contractor with the lowest bid was F & H Construction for \$6,668,000; however, they withdrew their bid because of a calculation error, which significantly lowered their intended bid price. The second lowest bid was submitted by Hawaiian Dredging for \$7,773,000 and the third lowest bid was submitted by Goodfellow Bros. for \$7,862,400.

The representative explained when a bid comes in higher than anticipated, the Department evaluates the margin between each bidder to determine whether there are calculation errors or missed items in the bid. He said in this particular instance, the lowest bidder made a calculation error of approximately \$800,000. He said adding the \$800,000 to the bid of \$6,668,000 would result in a bid amount of \$7,468,000, which is comparable to the second and third bidder. The representative said since the three bids are within a relatively small margin from one another, the Department is comfortable with the bid results. He said rebidding the Project would give the two highest bidders an opportunity to reevaluate their proposals and possibly reduce their bids to be competitive with the existing three low bids.

Your Committee stressed that the Reserve Fund was established to set aside funds for needed projects in the future and that its purpose was not to provide supplemental funding for cost overruns for projects. Your Committee requested the representative seek additional funds from the SRF, if available or other sources to fund the shortfall.

The Budget Director said because of the timing of the financial audit, the Department of Finance does not have the ability to certify a significant amount of Carryover/Savings at this time. Therefore, the decision was made to use the Reserve Fund to fund the shortfall.

The purpose of the proposed bill is to amend the FY 2019 Budget by 1) increasing Estimated Revenues for Other Intergovernmental by \$1,273,000; 2) amending Section 4.A.3.a.(2), Department of Environmental Management, Kihei-Makena Community Plan Area, Sewer, SRF, by adding an appropriation in the amount of \$1,273,000, for the Project; and 3) adjusting the totals accordingly.

2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 4856, BILL NO. 52 (2018), RELATING TO AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO INTERGOVERNMENTAL AGREEMENTS FOR LOANS FROM THE STATE OF HAWAII'S WATER POLLUTION CONTROL REVOLVING FUND FOR VARIOUS WASTEWATER PROJECTS, FISCAL YEAR 2019 BUDGET ORDINANCE" ("Bond bill").

The purpose of the proposed bill is to amend Ordinance 4856, Bill 52 (2018), to authorize the Mayor to enter into an intergovernmental agreement to finance the Project, with funds not to exceed \$1,273,000.

The Deputy Director of Environmental Management said following your Committee's meeting of September 18, 2018, the Department contacted the State Department of Health to inquire whether funds were available from the State of Hawaii Water Pollution Control Revolving Fund. The Department was informed additional SRF funding is available and the Department was able to secure the funds needed for the Project.

The Budget Director said because additional SRF funding is available, the proposed amendment to Appendix A for the use of the Reserve Fund is no longer needed.

Your Committee voted 6-0 to recommend passage on first reading the Budget bill, Bond bill, and Appendix C bill, and filing of the communication. Committee Chair Hokama, Vice-Chair White, and members Atay, Crivello, King, and Sugimura voted "aye." Committee members Carroll, Cochran, and Guzman were excused.

Your Committee is in receipt of a revised proposed Budget bill and a revised proposed Appendix C bill, approved as to form and legality by the Department of the Corporation Counsel, incorporating nonsubstantive revisions that take into account prior amendments to the FY 2019 Budget.

A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 4856, BILL NO. 52 (2018), RELATING TO AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO INTERGOVERNMENTAL AGREEMENTS FOR LOANS FROM THE STATE OF HAWAII'S WATER POLLUTION CONTROL REVOLVING FUND FOR VARIOUS WASTEWATER PROJECTS, FISCAL YEAR 2019 BUDGET ORDINANCE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4856, Bill No. 52 (2018), is amended by amending Section 1 to read as follows:

"SECTION 1. Request for Loan. The County of Maui, pursuant to Section 342D-83 through Section 342D-87, Hawaii Revised Statutes, has submitted an application for State Water Pollution Control Revolving Fund Loans ("SRF loans") to the Director of the Department of Health, State of Hawaii, to finance the following projects:

a. Kihei Wastewater Reclamation Facility Grit System Replacement \$6,500,000

b. Napili No. 3 Force Main Replacement \$1,800,000

c. Napili No. 4 Force Main Replacement \$1,800,000

d. South Maui Recycled Water System Expansion \$1,273,000

(collectively, "Projects").

Under the terms and conditions anticipated with regard to each such SRF loan, the County shall repay, over a term of twenty years, the principal amount, which shall not exceed the amount of each such loan stated above, at

a fixed rate of interest that shall not exceed the Bond Buyer's 20-year general obligation bond issue."

SECTION 2. Material to be repealed is bracketed. New material is underscored.

SECTION 3. This ordinance shall take effect upon its approval.
