Chair and Members:

Your Policy, Economic Development, and Agriculture Committee, having met on October 1, 2018, makes reference to County Communication 18-228, from the Chief of Police, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF THE DONATION OF (200) 2CT NALOXONE NASAL SPRAY UNITS, TRAINING/TRAVEL EXPENSES TO THE DEPARTMENT OF POLICE, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE."

The purpose of the proposed resolution is to authorize acceptance of the donation of (200) 2ct Naloxone nasal spray units, to counter opioid overdose and accidental opioid exposure for all police officers employed in the Department of Police, along with associated training and travel expenses, collectively valued at approximately \$16,000, from The Community Health Outreach Work ("CHOW") Project.

By correspondence dated September 10, 2018, the Department of the Corporation Counsel transmitted a revised proposed resolution entitled "AUTHORIZING ACCEPTANCE OF THE DONATION OF (200) 2-COUNT NALOXONE NASAL SPRAY UNITS, TRAINING/TRAVEL EXPENSES TO THE DEPARTMENT OF POLICE, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE."

The purpose of the revised proposed resolution is to correct the resolution's title to spell out "2-count" and incorporate other nonsubstantive revisions.

Your Committee notes Section 3.56.030, Maui County Code, requires Council approval by resolution of any gift or donation to the County.

A representative from the Department of Police ("Department") said the nasal spray units will be used primarily by officers accidentally exposed to opioids during their line of work. However, an officer will be able to administer the medication to others, if a public need arises.

The Department's representative said the 200 units will be distributed among 50 beats, with each beat receiving 4 units per district. The units have a shelf life of two years.

As part of the donation, the representative said the Department will be required to provide to The CHOW Project a donor report identifying the frequency of unit usage and situations when the units were used.

Your Committee recommended the resolution be revised to state that the data the County provides to The CHOW Project shall be proprietary to the County.

Your Committee notes the Department's Technical and Support Services Program received \$11,750 in the Fiscal Year 2019 Budget to purchase Narcan, also known as Naloxone, "for use by initial responding officers as an immediate and emergency treatment of a known or suspected opioid overdose."

Recognizing that opioid overdose is becoming a national epidemic, your Committee inquired whether nationwide data from other municipalities is available that could assist with obtaining Federal funding to deal with opioid overdose.

At the request of the Chair of your Committee, the Department of the Corporation Counsel transmitted a revised proposed resolution, approved as to form and legality, incorporating your Committee's


revisions. These revisions include adding a WHEREAS paragraph requiring the County to provide data to The CHOW Project relating to the frequency of unit usage and identify situations when the units were used, and stating that the data the County provides to The CHOW Project be proprietary to the County.

Your Committee voted 7-0 to recommend adoption of the revised proposed resolution and filing of the communication. Committee Chair Sugimura, Vice-Chair Crivello, and members Atay, Cochran, Guzman, Hokama, and King voted "aye." Councilmembers Carroll and White were excused.

Your Policy, Economic Development, and Agriculture Committee RECOMMENDS the following:

1. That Resolution _____, as revised herein and attached hereto, entitled "AUTHORIZING ACCEPTANCE OF THE DONATION OF (200) 2-COUNT NALOXONE NASAL SPRAY UNITS, TRAINING/TRAVEL EXPENSES TO THE DEPARTMENT OF POLICE, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE," be ADOPTED; and
2. That County Communication 18-228 be FILED.
