Chair and Members:

Your Policy, Economic Development, and Agriculture Committee, having met on October 1, 2018, makes reference to County Communication 18-230, from the Fire Chief, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF THE DONATION OF 61 PAIRS OF KAENON SUNGLASSES TO THE OCEAN SAFETY DIVISION OF THE DEPARTMENT OF FIRE AND PUBLIC SAFETY, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE."

The purpose of the proposed resolution is to authorize the acceptance of 61 donated pairs of Kaenon sunglasses, valued at approximately \$12,200, from the Hawaiian Lifeguard Association ("HLA"), to provide eye protection for County ocean safety officers employed in the Ocean Safety Division of the Department of Fire and Public Safety.

At the request of the Chair of your Committee, the Department of the Corporation Counsel transmitted a revised proposed resolution, entitled "AUTHORIZING ACCEPTANCE OF THE DONATION OF 61 PAIRS OF KAENON SUNGLASSES TO THE OCEAN SAFETY PROGRAM OF THE DEPARTMENT OF FIRE AND PUBLIC SAFETY, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE," approved as to form and legality, correcting the receiving program to read "Ocean Safety Program," instead of "Ocean Safety Division," and incorporating other nonsubstantive revisions.

Your Committee notes Section 3.56.030, Maui County Code ("MCC"), requires Council approval by resolution of any gift or donation to the County.

A representative from the Department of Fire and Public Safety ("Department") said the donated eyewear will be used by ocean safety personnel to help protect the employees' eyes from sun glare. He said each ocean safety officer will be allowed to select their preferred style of eyewear from an online site. Once ordered, the sunglasses will be shipped to the Department for distribution to the Department's 61 ocean safety officers.

A Deputy Corporation Counsel said the sunglasses would not be considered income for Federal tax purposes. He further said it would not be an ethical violation for an employee to receive the sunglasses because the sunglasses are not a gift from the HLA.

Your Committee notes an objective of the HLA is to actively support and promote the improvement and progression of lifesaving throughout the State of Hawaii.

The Department's representative said although the HLA has previously donated protective footwear to the County's ocean safety personnel, this is the first time they have donated protective eyewear. The eyewear manufacturer, Kaenon, will provide the sunglasses to the HLA, who in turn will donate the sunglasses to the County. He added the County would not be responsible for replacing an employee's sunglasses if they are damaged or stolen.

The Deputy Corporation Counsel confirmed the donation is not an endorsement of Kaenon by the County, nor does the donation constitute a sponsorship under Section 13.04A.430, MCC.

Your Committee voted 6-0 to recommend adoption of the revised proposed resolution and filing of the communication. Committee Chair Sugimura, Vice-Chair Crivello, and members Atay, Cochran, Guzman, and Hokama voted "aye." Committee members Carroll, King, and White were excused.
