The Department of Planning (Department) is in receipt of an email dated October 29, 2018 from Traci Fujita, regarding the above-referenced item for review by the Planning Committee.

Question #1, as stated in the email, "Of the pending and permitted operations, how many have properties that abut the shoreline?" The Department's response is as follows:
