RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS,
DEPARTMENT OF PUBLIC WORKS
(FEDERAL HIGHWAY ADMINISTRATION, FEDERAL-AID AND
OTHER TRANSPORTATION GRANTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4861, Bill No. 57 (2018), as amended, "Fiscal Year 2019 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2019, is hereby amended as it pertains to the Department of Public Works, by increasing the appropriation for Federal Highway Administration, Federal-Aid and Other Transportation Grants by \$1,020,000, to read as follows:

"11. Department of Public Works

a. Federal Highway Administration, Federal-Aid and Other Transportation Grants	[12,500,000]	<u>13,520,000</u>
b. Federal Highway Administration, Transportation Alternatives Program Grants		200,000
c. State of Hawaii Department of Transportation – Safe Routes to School Program Special Fund		275,000
d. State of Hawaii Department of Transportation – Keanae Road Safety Improvements		2,000,000
e. State of Hawaii – Old Haleakala Highway Sidewalk		3,000,000"
