SUBJECT: **ONE FARM PLAN** (PEA-37)

At its meeting of July 17, 2017, the Policy, Economic Development, and Agriculture Committee discussed the application processes to receive benefits or exemptions for agriculture in the County, including agricultural rates for real property tax, farm plans for farm dwellings, and special water rates. The Committee was fortunate to hear from representatives from the Departments of Finance, Planning, and Water Supply, and the Office of Economic Development, on application criteria and procedures.

The Departments uniformly supported systemic changes that would ease the burden on applicants in applying for these benefits.

May I request the Department of Management coordinate work among these Departments and the Office of Economic Development to simplify and consolidate these application processes?

May I also please request you and the noted agencies consider the following relating to this matter:

- 1. The attached response dated July 12, 2017, from the Department of Water Supply, suggesting changes for the application for special water rates.
- 2. Viable ways to reduce application paperwork for farms, including farms encompassing multiple tax map keys (TMKs).
- 3. Can inspections by the Departments also be coordinated and consolidated so as to reduce overlap and multiple visits? By consolidating inspections, would there be a means of triggering inspections without receipt of complaints or monitoring by neighbors?

4. At the meeting, the Assistant County Real Property Tax Administrator referred to agricultural dedications as another means of achieving financial benefits through agricultural use. Would it be advisable to also link this form to the webpage of agriculture benefits and exemptions until a more comprehensive solution is reached?

Additionally, please provide the following information:

- 1. To what extent can the Maui Automated Planning and Permitting System, also known as MAPPS, facilitate the consolidation of the application processes for agriculture benefits and exemptions? Can efficiencies and consolidation be gained prior to the anticipated rollout of MAPPS in August 2018? Please explain.
- 2. Can the AX system data generated by the Department of Finance be shared with the Departments of Planning and Water Supply to create efficiencies and reduce collection of redundant information? Please explain and describe the system and its usage.

The Committee plans to schedule the item for further discussion in September. May I therefore request a response to the above questions, and an overall update on the application consolidation process **no later than Wednesday, August 16, 2017.** To ensure efficient processing, please include the relevant Committee item number in the subject line of your response.

SUBJECT: FEDERAL FOOD SAFETY MODERNIZATION ACT (FSMA) (PEA-29)

As requested in your letter of June 7, 2017, we have reviewed the list of requirements under Section 14.10.010, Maui County Code (Code). The Department of Water Supply recommends amending the Code to continue to provide adequate, yet reasonable documentation by changing the following:

- 1. Revise the requirement for Form G-45 to Form G-49, General Excise/Use Annual Return & Reconciliation.
- 2. Revise the annual requirement for: consumer's filed Internal Revenue Service Profit or Loss from Farming Schedule F; age of the commercial crop or stock; five-year timeline of projected annual gross income; and a site-plan. This information should be provided with the first application and only as requested by the Department of Water Supply thereafter.

3. Revise Maui County Code Section 14.01.040 to read:

"Agricultural consumer" means a consumer that actively engages in crop production, livestock raising, dairy farming, or aquaculture for commercial production, and whose minimum gross income from such activities is \$5,000.

We believe the foregoing changes will alleviate some of the administrative burden for agricultural consumers while providing reasonable documentation to help us ascertain legitimate agricultural water consumption. We hope you are able to propose these changes.
