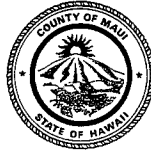

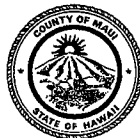

A BILL FOR AN ORDINANCE TO AMEND SECTION 20.40.020, MAUI COUNTY  
CODE, RELATING TO THE DEFINITION OF "SAND MINING"

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 20.40.020, Maui County Code, is amended by  
amending the definition of "sand mining" to read as follows:

"Sand mining" means extraction and removal of sand from a  
lot, except for the following:

1. Activities required to comply with county, state,  
or federal regulations.

2. Activities related to land management for  
agriculture, landscaping, and related uses as described in  
subsection 20.08.030(C) of this title where no inland sand is  
transported outside the same lot.

[3. Activities conducted pursuant to a valid permit  
issued prior to the effective date of this ordinance.]

SECTION 2. Material to be repealed is bracketed. In printing this bill, the  
County Clerk need not include the brackets or the bracketed material.

SECTION 3. This ordinance shall take effect upon its approval.
