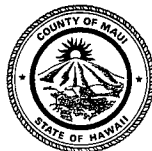

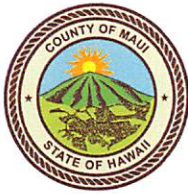

**SUBJECT: TRANSFERS/LOANS FROM THE GENERAL FUND AND DWS  
REVENUE FUND TO THE 2017 PROPOSED GO BOND FUND-AS  
OF SEPTEMBER 30, 2018**

Dear Chair White and Members:

In accordance with Section 18 of General Budget Provisions of Ordinance No. 4456, Fiscal Year 2018 Budget, attached is a summary of transfers that have occurred from the General Fund and Department of Water Supply (DWS) Revenue Fund to the 2017 Proposed General Obligation Bond Fund as of September 30, 2018.

Based on the attached report, the Department of Finance estimates that the County of Maui's next general obligations bond issuance will be by end of FY2018. As stated in Section 18 of the General Budget Provision, "the transfer or loan will be reimbursed or repaid within twenty-four (24) months after the later of: (i) the date of the transfer or loan; or (ii) the date that the public improvement funded by the transfer or loan was placed in service, but in no event later than three (3) years) after the expenditures has been made."
