This AMENDMENT NO. 2 TO CONTRACT is made and entered into by and between the COUNTY OF MAUI, a political subdivision of the State of Hawaii, whose business address is 200 South High Street, Wailuku, Maui, Hawaii 96793, hereinafter referred to as the "County", and GROUP 70 INTERNATIONAL, INC., a Hawaii corporation, dba G70, whose mailing address is 925 Bethel Street, Fifth Floor, Honolulu, Hawaii 96813, hereinafter referred to as the "Contractor." County and Contractor shall hereinafter be referred to collectively as the "Parties".

<u>Source of Funds</u>. The source(s) and availability of the funds for this Contract shall be as set forth in the Contract Certification signed by the Director of Finance of the County of Maui on or before the effective date of this Contract. Contract Certification shall be on file in the office of the Director of Finance of the County of Maui.

NOW, THEREFORE, the Parties mutually agree to amend the Contract as follows:

1. Section 2., <u>Time of Performance</u>, is amended to read as follows:

2. <u>Time of Performance</u>. The Contractor shall commence performance under this Contract upon issuance of the Notice to Proceed, and shall continue performance through March 1, 2019, unless sooner completed, terminated, or extended in compliance with the terms of this Contract. Where the contract work is structured into phases or discrete work items, if the commencement of a phase or work item is triggered not by the completion of the prior phase or work item, but by some other event not under the control of the Contractor, the time between the completion of one phase or work item and the commencement of the next shall not count towards the time of performance within which the Contractor agreed to complete its performance under the Contract. The Contractor agrees to cooperate and coordinate with the County to accurately compute and document the time of performance.

The entire Contract, as amended herein, shall remain in full force and effect.
