

A BILL FOR AN ORDINANCE AMENDING SECTION 3.36.030, MAUI COUNTY CODE, RELATING TO THE MAUI COUNTY GRANTS PROGRAM

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 3.36.030, Maui County Code, is amended to read as

follows:

**"3.36.030 Soliciting applications.** <u>A.</u> When an appropriation is available for allocation, other than to a recipient identified in the annual budget or amendments thereto, the agency shall post on the County website and publish in the local newspaper the availability of the appropriation, and shall solicit applications.

B. Recipients specifically identified in the annual budget, or amendments thereto, for a grant of funds shall not be eligible to apply for another grant of funds for the same fiscal year pursuant to this chapter."

SECTION 2. New material is underscored. In printing this bill, the County

Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect on July 1, 2018.
