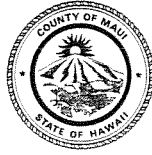

BILL NO. _____ (2018)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.08, MAUI COUNTY
CODE, RELATING TO FORBEARANCE OR DISCHARGE OF DEBTS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 3.08, Maui County Code, is amended by adding a
new section to be appropriately designated and to read as follows:

“3.08.025 Forbearance or discharge of debts. The
council shall approve, by resolution, any forbearance or discharge
of debt owed to the County. This section shall not apply to
uncollectible delinquent taxes pursuant to section 3.48.286 of this
chapter, uncollectible delinquent penalties and interest pursuant
to subsection 3.48.010(N) of this chapter, and shall not limit any
director’s authority to waive daily fines assessed under section
19.530.030 of this code and any rules adopted thereunder.”

SECTION 2. New material is underscored. In printing this bill, the
County Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect on July 1, 2018.
