Chair and Members:

Your Policy, Economic Development, and Agriculture Committee, having met on October 29, 2018, makes reference to County Communication 17-7, from Council Chair Mike White, relating to nominations to boards, committees, and commissions.

By correspondence dated and received on October 19, 2018, the Mayor transmitted a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF JAMES JONES TO THE KULA AGRICULTURAL PARK COMMITTEE," along with a completed application for the nominee. The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of James Jones to the Kula Agricultural Park Committee for a term expiring on March 31, 2020, to fill a vacancy due to the resignation of Paul Otani.

Your Committee notes general appointment procedures for boards and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code ("MCC").

Your Committee notes specific provisions for the Kula Agricultural Park Committee are outlined in Sections 2.40.180 and 22.04A.070, MCC.

Your Committee further notes there is no time limitation for Council to approve or disapprove the nomination.

Your Committee did not request to interview the nominee.

A representative of the Mayor said Mr. Jones has been the owner and operator of Pukalani Plant Company since 1992. He previously served as the Chair of the Kula Agricultural Park Committee and has knowledge and experience that will be helpful to the Committee.

Your Committee noted Section 22.04A.070, MCC, states the Kula Agricultural Park Committee shall consist of nine members representing various groups, if reasonably possible, one of which is a tenant of the Kula Agricultural Park. Your Committee confirmed Mr. Jones is a current tenant of the Park.

Your Committee was satisfied with Mr. Jones' application and expressed gratitude to him for volunteering to serve the community.

Your Committee voted 6-0 to recommend adoption of the proposed resolution. Committee Chair Sugimura, Vice-Chair Crivello, and members Atay, Carroll, Hokama, and King voted "aye." Committee members Cochran, Guzman, and White were excused.
