- Her vision includes affordable housing and economic stability for our labor force, achieving the Aloha + Challenge sustainability goals, preserving and protecting cultural, historic, and environmentally sensitive areas, and efficiently managing our resources to sustain current and future generations.
- She understands the plan is for the community and it needs to be by the community. She understands the community needs to work together to create holistic solutions to the challenges that our community faces.

- One of her concerns is the overdevelopment of luxury properties. She believes in a moratorium on the building of luxury housing because there is not enough housing for workers, but there are a lot of luxury housing for people who do not reside here.

- Concerned about development in West Maui. Also concerned about the ability to build affordable housing and not interfere with traffic, impact our sewage disposal, drinking water, and ultimately, polluting the ocean and beaches.

### Dawn Hegger-Nordblom

- Resides in Kapalua. Attended Seabury Hall in 1987.
- Owns Ke Kai Planning, an urban planning firm that provides professional planning services for nonprofits, the private sector such as engineers, lawyers, developers, and architects, and agencies at the county, state, and federal level. Also works parttime/temporary for Trilogy.
- Has worked for DLNR as a Regulatory Planner, was a Program Manager with the Honolulu Area Rapid Transit Authority, and was a Planner for the County. Has worked on affordable housing in Kakaako for the Hawaii Community Development Authority. Has also worked for the Hawaii Army National Guard as a Program Manager.
- She is very interested in the environment, how development affects the environment, shoreline erosion, beach nourishment, failing infrastructure, the possible road realignment of Honoapiilani Highway, and affordable housing.
- Would like to see about addressing tourism numbers so local people can enjoy recreational areas and that marine environment is protected.
- Would like to see people who actually live in Lahaina be able to afford to live and work in Lahaina.
- She has been assisting with the draft of the West Maui Community Disaster Plan.

- Currently a substitute teacher at Princess Nahienaena. Has a bicycle shop on the side.
- Educational background is in anthropology.
- Was a foreman on the jury for Pulama Heights, a member of the Board of Appeals under Mayor Tavares, attended numerous presentations by the Planning Department to the Planning Commission. Is a licensed Fabmac dealer. Was President of the Maui County Veterans Council. Currently President of the West Maui Veterans Club.
- Housing needs to be seen from the developers' point of view and the non-developers'
  point of view. People need to see both sides, otherwise housing will not happen. A plan
  for disaster management such as volunteer firefighters would allow for a better
  response in time of disasters. Would like to get things done with no negative impact on
  the people.
- He is not registered with a political party.

### Michele Lincoln

- Resides in Lahaina, specifically the Kahoma ahupuaa by the Kahoma Stream. Came to Maui in 1982.
