





WHEREAS, by letter dated January 2, 2019, Mayor Michael P. Victorino notified the Council that he appointed Karla H. Peters as the Director of the Department of Parks and Recreation, pursuant to Sections 6-2(5) and 8-6.2 of the Revised Charter of the County of Maui (1983), as amended (“Charter”); and

WHEREAS, Charter Section 6-2(5) requires the Council to confirm or deny the appointment within sixty (60) days after receiving notice of the appointment by the Mayor; and

WHEREAS, Charter Section 8-6.2 states that “[t]he director of parks and recreation shall be appointed by the mayor with the approval of the council”; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:
