We, the Credit Unions of the County of Maui, would like to humbly express our support for Mr. Scott Teruya for his appointment as the Director for the Department of Finance for the County of Maui.

As the Administrator for the Real Property Tax Division, Mr. Teruya lead the department to be recognized nationally and internationally in receiving the International Association of Assessing Officers Certificate of Excellence in Assessment Administration. On July 6, The County Council passed a Resolution No. 18-114 congratulating the Real Property Tax Assessment Division. The award is a testament to Mr. Teruya's leadership and the efforts of all the department employees.

Mr. Teruya was also instrumental in creating the Real Property Tax Collection service by the Credit Unions of the County of Maui in 2017. On the basis expressed above please favorably consider confirming Mr. Teruya as the Director for the Department of Finance for the County of Maui.


