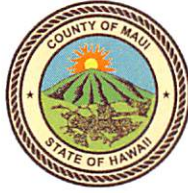

Kehalani Mauka (Large-Lot) Subdivision No. 3-C Description of Easement 1-D (Waterline Easement)

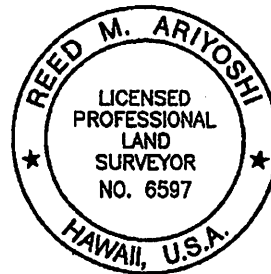
A Waterline Easement 1-D in favor of the County of Maui, over and across a portion of Lot OS-1 of Kehalani Mauka (Large-Lot) Subdivision No. 3-C, also affecting a portion of Royal Patent 1925, 1928, 1958, Land Commission Award 387, Part 5, Section 1 to A.B.C.F.M. at Wailuku, Maui, Hawaii and being more particularly described as follows:

Beginning at a point at the most northerly corner of this easement, being also the most northerly corner of Lot OS-1 of Kehalani Mauka (Large-Lot) Subdivision No. 3-C, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being: 857.28 feet South and 6,682.09 feet West and running by azimuths measured clockwise from True South:

1. 24° 30' 79.43 feet along Lot 3-A-1-D-1 of Kehalani Mauka (Large-Lot) Subdivision No. 3-C, being also along the remainder of Royal Patent 1925, 1928, 1958, Land Commission Award 387, Part 5, Section 1 to A.B.C.F.M.;
2. 124° 05' 45.42 feet along the remainder of Lot OS-1 of Kehalani Mauka (Large-Lot) Subdivision No. 3-C, being also along the remainder of Royal Patent 1925, 1928, 1958, Land Commission Award 387, Part 5, Section 1 to A.B.C.F.M.;

3. 236° 26'

84.68 feet along Lot 7 (Road-Widening Lot) of Kehalani Mauka (Large-Lot) Subdivision No. 1, being also along the remainder of Royal Patent 1925, 1928, 1958, Land Commission Award 387, Part 5, Section 1 to A.B.C.F.M. to the point of beginning and containing an Area of 1,779 Square Feet, more or less.
