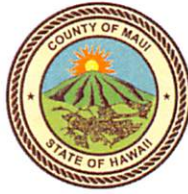

Pursuant to Section 3.44.015 H. of the Maui County Code, this letter shall serve as notice that the County of Maui has accepted the Dedication of an Easement "S-1" by the Department of Environmental Management – Wastewater Reclamation Section. The parcel is identified by the subject Tax Map Key Number.

Please refer to enclosed Exhibit A for the Legal Description of the Easements and Exhibit B for an Easement Map & Property Location.

In addition, the Department of Environmental Management has provided additional information pursuant to Section 3.44.015, F.1 of the Maui County Code.

- 1) **County Funds:** No County Funds used.
- 2) **Project Name:** 83 Mission Street

COUNTY COMMUNICATION NO. 19-44

- 3) **Purpose:** For Underground Sewerline Purposes, including Manholes and other equipment and appurtenance necessary.
- 4) **Dedication:** Proposed sewer system improvements consisting of an existing 6-inch vitrified clay pipe sewerline installed in 1933. All of the sewer system improvements have been confirmed to be located within stated easement area.
- 5) **Conformance:** Easement location and width is acceptable to the Department of Environmental Management and is in conformance with County standards.

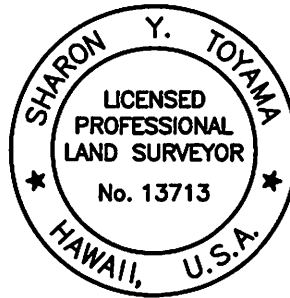
**EASEMENT S-1

Beginning at the North corner of this easement, being also the North corner of Lot 2 on the Southwesterly side of Mission Street, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being:

623.49 feet West

1.	326°	30'	15.00	feet along the Southwesterly side of Mission Street;
2.	56°	34'	173.18	feet along the remainders of Lot 2 and Lot 1 of a portion of land awarded by the Commissioners of Crown Lands to R. Keahi, being also the remainder of Pruvia Goodness lot as described on Dang Tract (File Plan 261);
3.	147°	11'	15.00	feet along Lot 6-B of Spreckels Tract, being also along Royal Patent 1996, Land Commission Award 420 to Kuihelani;
4.	236°	34'	173.00	feet along Lot 21 and Lot 24 of Amori Tract (File Plan 212), being also along the remainders of land awarded by the Commissioners of Crown Lands to R. Keahi to the point of beginning and containing an area of 2,596 Square Feet.

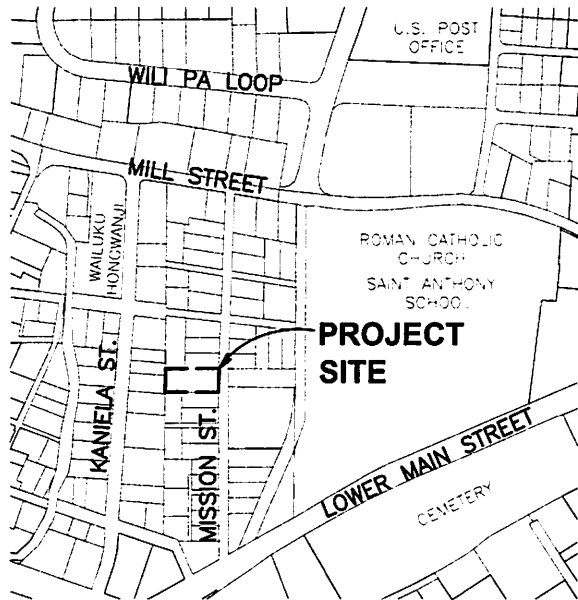

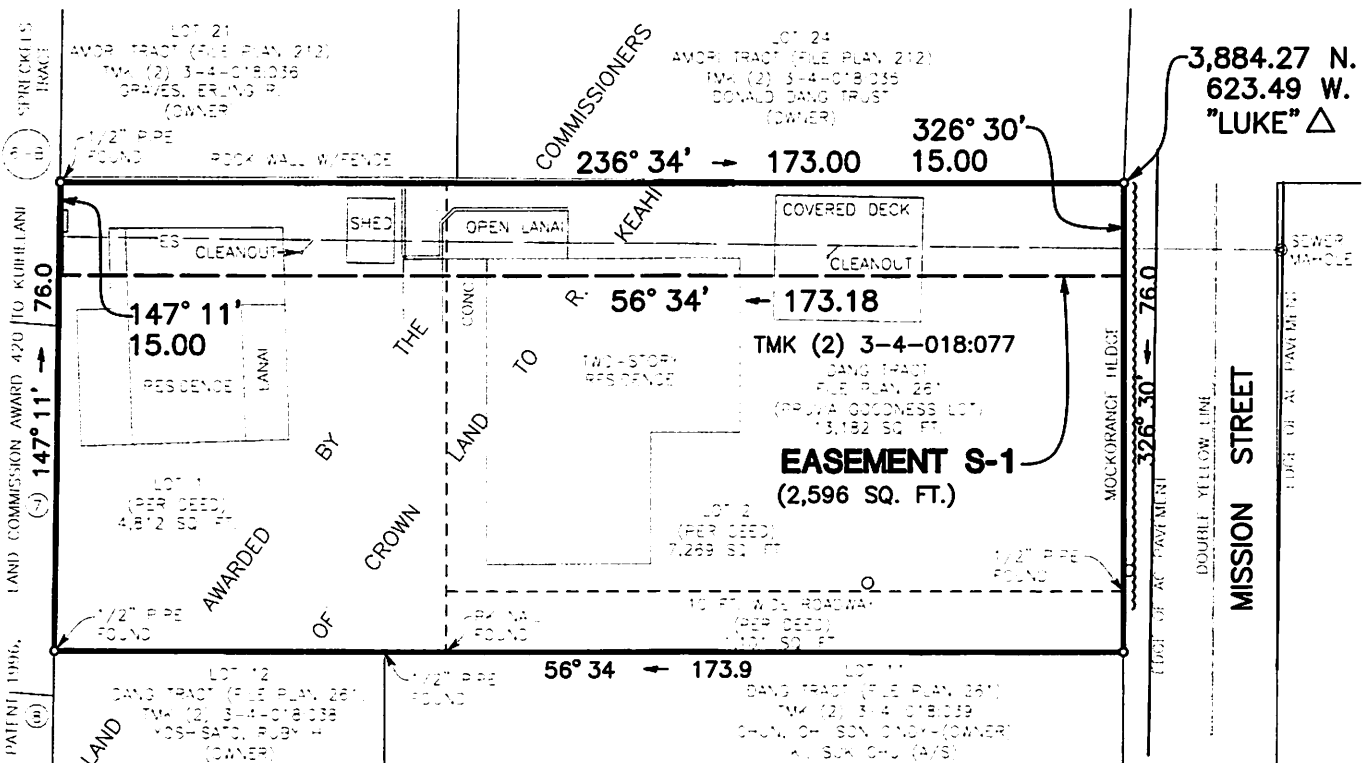
