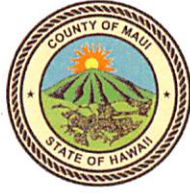

Pursuant to Section 3.44.015 H. of the Maui County Code, this letter shall serve as notice that the County of Maui has accepted the dedication of a Fire Hydrant Easement "A" by the Department of Water Supply – Engineering Division. The parcel is identified by the subject Tax Map Key Number.

Please refer to enclosed Exhibit A for the Legal Description and Exhibit B for the location of each Easement.

In addition, the Department of Water Supply has provided additional information pursuant to Section 3.44.015, F.2 of the Maui County Code.

- 1) **County Funds:** No County funds used.
- 2) **Purpose:** Access to a fire hydrant and for waterline purposes, including other equipment and appurtenances necessary or expedient for the proper maintenance, operation or repair of such fire hydrant or pipelines installed within said easement.

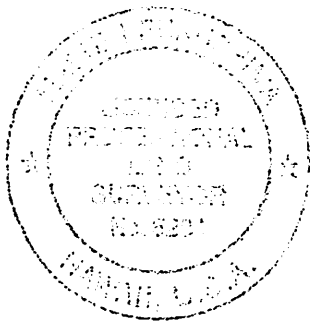
EASEMENT "A"
(FIRE HYDRANT PURPOSES)

Being Parcel 5 of Tax Map Key: (2) 3-4-010, being also a portion of Royal Patent 1996, Land Commission Award 420 to Kuihelani.

Situate at Owa, Wailuku, Maui, Hawaii.


Beginning at the Northeast corner of this easement and being also the West corner of Wells Street and Waiale Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being 2,379.21 feet North and 608.29 feet West and running by azimuths measured clockwise from true South:

1. 16° 27' 30" 10.01 feet along the West side of Waiale Road;
2. 104° 09' 00" 5.00 feet along the remainder of R.P. 1996, L.C. Aw. 420 to Kuihelani;
3. 196° 27' 30" 10.01 feet along the remainder of R.P. 1996, L.C. Aw. 420 to Kuihelani;
4. 284° 09' 00" 5.00 feet along the South side of Wells Street to the point of beginning and containing an area of 50 square feet.

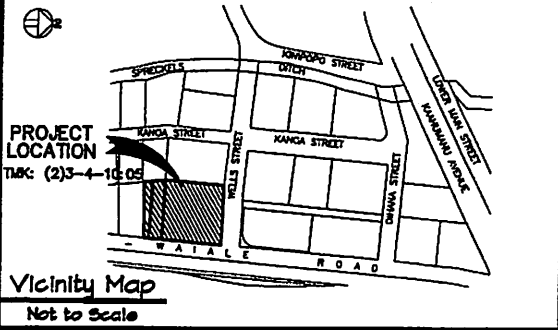

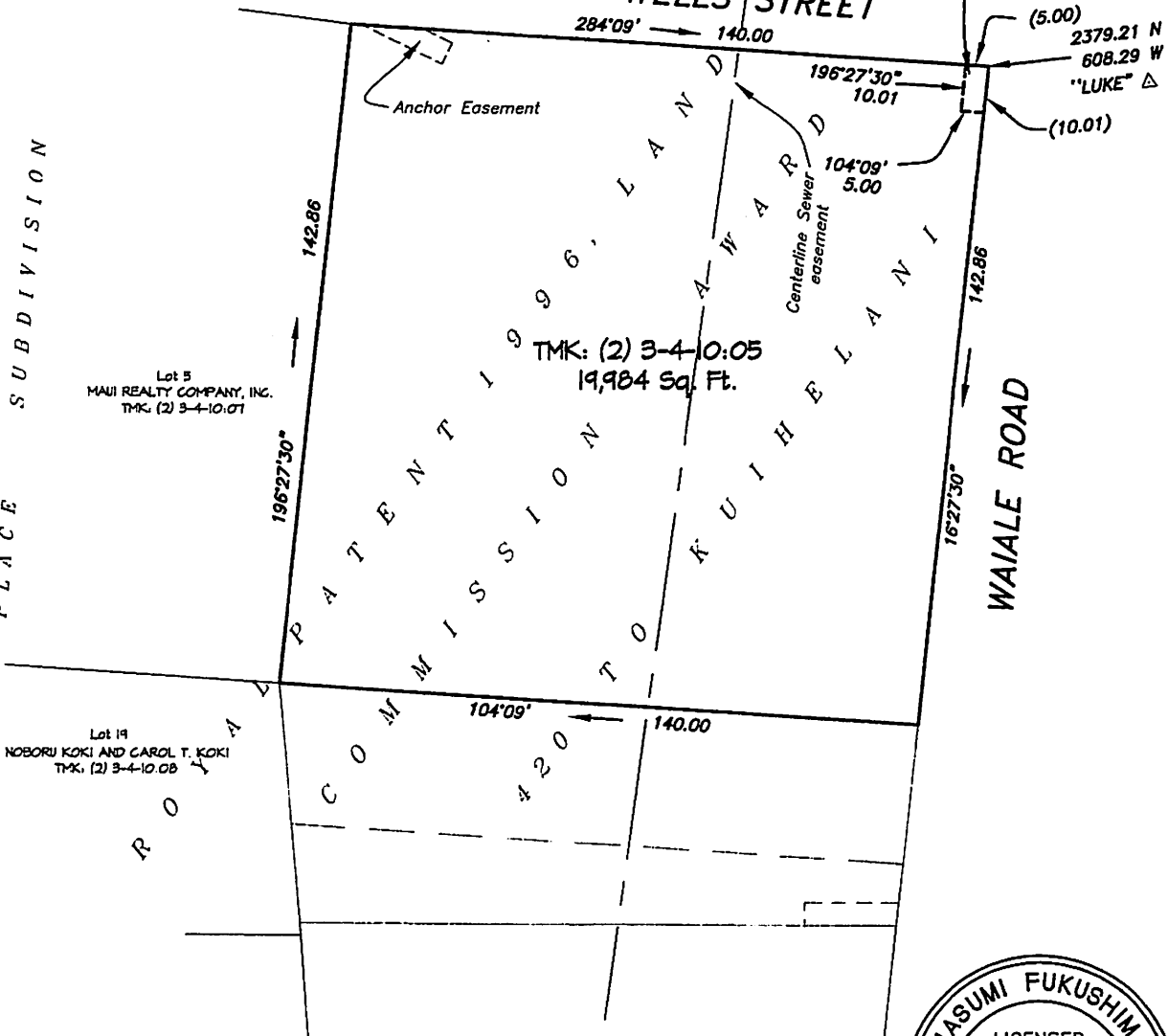
TRUE NORTH

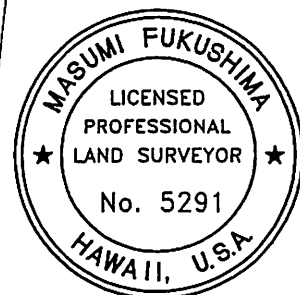
