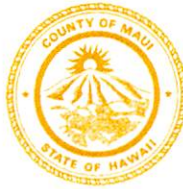

SUBJECT: AMENDMENT TO THE FISCAL YEAR 2019 BUDGET

On behalf of the Department of Fire and Public Safety, I am transmitting the attached proposed bills for the purpose of amending the Fiscal Year 2019 Budget by increasing the appropriation under the Department of Finance, Countywide Equipment for equipment purchases for the Department of Fire and Public Safety.

Ordinance 4932 (2018) amended the Fiscal Year 2019 Budget, as it relates to the Bond Fund, to include \$1,552,000 for two 1500 GPM pumper trucks, one each for the Kihei and Napili Fire Stations; \$1,347,000 for a ladder truck for the Wailea Fire Station; and \$152,000 for a portion of one brush truck each for the Lahaina and Kahului Fire Stations. The Fiscal Year 2019 Budget also appropriates \$300,000 from the General Fund for the brush trucks.

A consolidated bid for all five fire apparatus was received from Hughes Fire Equipment. The bid amount of \$3,509,100 includes considerable discounts if all five trucks are purchased at one time. A copy of the bid is attached for your reference.

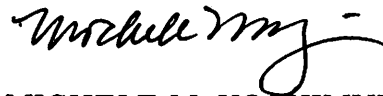

BILL NO. 54 (2018), RELATING TO THE ISSUANCE OF GENERAL
OBLIGATION BONDS OF THE COUNTY OF MAUI
ISSUANCE, SALE AND DELIVERY OF SAID BONDS
(DEPARTMENT OF FINANCE – COUNTYWIDE
EQUIPMENT)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4858, Bill No. 54 (2018), is amended by
amending Section 1 to read as follow:

SECTION 1. Authorization of General Obligation Bonds. Pursuant to Chapter 47, Hawaii Revised Statutes, as amended, and particularly Part I thereof, there are hereby authorized to be issued and sold from time to time general obligation bonds of the County of Maui, State of Hawaii (the "County") in an aggregate principal amount not to exceed ~~[\$76,200,000]~~ \$76,358,100 (the "Bonds"), the proceeds derived from the sale of which shall be used to pay all or part of the cost of appropriations for the public improvements of the County described in Section 2 hereof.

SECTION 2. Disposition of Bond Proceeds. All or any portion of the proceeds derived from the sale of the Bonds or any notes issued in anticipation of the Bonds shall be used to pay all or part of the cost of any of the public improvements listed below in accordance with appropriations contained in the Fiscal Year 2019 Budget, including amendments and supplements thereto, duly approved by the Council of the County (the "Council") for the fiscal year ending June 30, 2019 (the "Fiscal Year 2019 Budget"); provided, however, that pursuant to Section 47-5, Hawaii Revised Statutes, the part of such proceeds which are in excess of the amounts required for the purposes for which the Bonds are initially issued from time to time, or which may not be applied to such purposes, or which the Council deems should not be applied to such purposes, may be applied to finance such other public improvements of the County as the Council shall, by ordinance approved by an affirmative vote of two-thirds of all of its members, determine; and provided further that the actual use and application of the proceeds of Bonds issued pursuant to this ordinance shall not in any way affect the validity or legality of such Bonds. No proceeds of the Bonds shall be applied to any public improvement listed in this section unless and until there shall be a valid appropriation of general obligation bond proceeds in effect for such public improvement. The public improvements provided for or to be provided for in the Fiscal Year 2019 Budget, to be financed with proceeds from the sale of the Bonds, are as follows:

If the County would like to consider a pre-payment of less than 100% the available deduction will be provided upon request. If not elected payment is due Net 30 days of delivery of apparatus to customer's facility.

Please Note: Transportation funds have been included to transport all of the above apparatus under its own power. If, due to Federal and/or State DOT regulations or customer preference, delivery via flatbed or rail system is necessary additional transportation charges will be required. If we are unable to obtain the necessary permits to transport the apparatus to the customer's location, the customer will be responsible for transporting the apparatus from the manufacturer's facility to the customer's location.
