I am writing in support of Confirmation of Mr. Dave Goode as the Director of the Department of Public Works for the County of Maui.

Dave has the necessary experience and qualifications to do the job. He has worked under three previous Mayors and over 30 council members. He has both public and private sector experience and is a level-headed leader. I have served with him on a volunteer nonprofit board and found him to be reliable and generous with his time.

Maui County has two large, important projects that were started by the previous administration over two years ago.

- 1- Title 19 review and revisions working with both government and the general public to update our Zoning codes to incorporate the community plans and land use. To eliminate interim zoning and clarify what land use is allowed on each parcel of land.
- 2- MAPPS, Maui Automated Permit Processing System. A part of the Tyler technologies planning and Land use Platform. Incorporating GIS maps for both public and private users to identify information about each parcel of land in Maui County. GIS and MAPPS will enable both Public Works and the Planning Department to monitor approvals and enforcement of permits and zoning.

We are shifting from inefficient paper plans to digital submittal in all the departments simultaneously. The one-stop shop advocated for years by our public. This program will enable public workers to be more efficient with time spent on review and confirming compliance. It will free up a lot of space currently being used for rooms full of paper plans. It will enable a free flow of review and commits between the departments and also enable various industry and private application to see where their submittal is in the system.

The current KIVA system is like an eight-track tape where MAPPS is limitless cloud computing.

Dave Good, Michelle McLean, Sandy Baz, Will Spence were all part of the reviewing and planned implantation of these important programs. <u>I humbly request you unanimously approve their reappointment</u> with the understanding of an annual assessment of these programs will be made. It will take "unfortunately" two years to made significant progress to implement these programs. But I firmly believe it is the pathway to a clear land use policy that will enable our community to work together and get nonspeculative shared equity homes and apartments made for our local families.

I ask our new County Council to demonstrate it's a willingness to collaborate with the new Mayor. Let's work together as a united community. The learning curve for new Directors will set these programs back years. You the council will review and approve or modify all outcomes of this work.
